## AN ACT

- Amending the act of July 9, 1987 (P.L.220, No.39), entitled "An 1 act licensing and regulating the practice of social work; providing penalties; and making an appropriation," further 3 providing for definitions, for the licensing agency and its functions, for powers and functions of board, for 4 5 qualifications for license, for procedures for licensing, for 6 reciprocity and for reinstatement of license; providing 7 for nomenclature; and further providing for penalties, for 8 license renewal and records and fees and for unlawful 9 10 practice. The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. The definition of "provisional licensed social worker" in section 3 of the act of July 9, 1987 (P.L.220, 14 15 No.39), known as the Social Workers, Marriage and Family Therapists and Professional Counselors Act, amended December 21, 16 17 1998 (P.L.1017, No.136), is amended and the section is amended 18 by adding definitions to read: 19 Section 3. Definitions.
- The following words and phrases when used in this act shall

3	"Licensed bachelor social worker." A social worker who holds
4	a current bachelor's level license under this act.
5	* * *
6	"Practice of bachelor social work." A licensed bachelor <
7	social worker providing generalist, nonclinical social work
8	services as an employee functioning under the direction of
9	an individual who is regulated by the Commonwealth or holds
10	a professional license issued by the Commonwealth, or an
11	individual employed by an agency that is regulated by the
12	Commonwealth. The term includes performing any of the following
13	<u>functions:</u>
14	(1) Providing social work case management services of a
15	generalist, nonclinical nature as an employee of an agency or
16	a health care facility.
17	(2) Providing consultation on generalist, nonclinical
18	issues to individuals, groups, members of other professional
19	disciplines, agencies, health care facilities or
20	<u>institutions.</u>
21	(3) Obtaining information from agency clients or
22	applicants for services to determine their social work
23	service needs or the availability of appropriate resources.

CODE § 1153.52 (RELATING TO PAYMENT CONDITIONS FOR VARIOUS SERVICES). A LICENSED BACHELOR SOCIAL WORKER MUST WORK UNDER THE 15 16 DIRECTION OF AN INDIVIDUAL WHO IS ABLE TO SUPERVISE AND DIRECT 17 THE ACTIVITIES OF THE LICENSED BACHELOR SOCIAL WORKER. LICENSED 18 BACHELOR SOCIAL WORKERS MAY NOT PRACTICE IN A PRIVATE SETTING, 19 PRACTICE INDEPENDENTLY OR ENGAGE IN CLINICAL SOCIAL WORK 20 PRACTICE OR HOLD THEMSELVES OUT AS LICENSED SOCIAL WORKERS OR 21 LICENSED CLINICAL SOCIAL WORKERS. BACHELOR SOCIAL WORKERS ARE 22 NOT PERMITTED TO BILL A HEALTH INSURANCE PLAN FOR SERVICES

- 25 (g) Bachelor social work license. -- An applicant shall be
- 26 qualified for a license to hold oneself out as a licensed
- 27 <u>bachelor social worker if the applicant submits proof</u>
- 28 satisfactory to the board that:
- 29 <u>(1) He or she THE APPLICANT is of good moral character.</u> <
- 30 (2) He or she THE APPLICANT has received a bachelor's <-

1	<u>degree from an accredited school PROGRAM of social work or</u>
2	social welfare.
3	(3) He or she THE APPLICANT has passed an examination <-
4	duly adopted by the board.
5	(4) His or her application has been THE APPLICANT HAS <-

- 2 (b) Issuance of license. -- The board shall issue to each
- 3 person who meets the licensure requirements of this act a
- 4 certificate setting forth that such person is licensed to hold
- 5 himself or herself out as a licensed bachelor social worker, a
- 6 licensed social worker, [a provisional social worker,] a
- 7 licensed clinical social worker, a licensed marriage and family
- 8 therapist or a licensed professional counselor.
- 9 Section 10. Reciprocity.
- 10 The board shall have the power to grant a reciprocal license
- 11 to an applicant who is licensed or certified as a <u>bachelor</u>
- 12 <u>social worker</u>, social worker, clinical social worker, marriage
- 13 and family therapist or professional counselor in another state
- 14 and has demonstrated qualifications which equal or exceed those
- 15 required pursuant to this act in the determination of the board,
- 16 provided that no license shall be granted under this section to
- 17 an applicant unless the state in which the applicant is licensed

- 21 Unless ordered to do so by Commonwealth Court or an appeal

- 25 counselor pursuant to this act, which has been revoked. Any
- 26 person whose license has been revoked may apply for
- 27 reinstatement, after a period of at least five years, but must
- 28 meet all of the licensing qualifications of this act, including
- 29 the examination requirement, if he or she desires to practice as
- 30 a bachelor social worker, social worker, clinical social worker,

- 23 minimum of three members, whichever is greater, may levy a civil

(1) All fees required pursuant to this act shall be-

- 18 fixed by the board by regulation and shall be subject to the
- 19 act of June 25, 1982 (P.L.633, No.181), known as the
- 20 Regulatory Review Act. If the revenues raised by fees, fines
- 21 and civil penalties imposed pursuant to this act are not
- 22 sufficient to meet expenditures over a two-year period, the
- 23 board shall increase those fees by regulation so that the
- 24 projected revenues will meet or exceed projected
- 25 expenditures.
- 26 (2) If the Bureau of Professional and Occupational
- 27 Affairs determines that the fees established by the board
- 28 pursuant to paragraph (1) are inadequate to meet the minimum-
- 29 enforcement efforts required by this act, then the bureau,

- 11 (a) Unlawful practice prohibited. -- It shall be unlawful for
- 12 any person to hold himself or herself out as a <u>licensed bachelor</u>
- 13 <u>social worker</u>, licensed social worker, licensed clinical social
- 14 worker, marriage and family therapist and professional counselor
- 15 without possessing a valid, unexpired, unrevoked and unsuspended
- 16 license issued under this act.

- 19 Family Therapists and Professional Counselors shall add licensed
- 20 bachelor social workers to the licensees who must comply with
- 21 regulations governing codes of ethical practice and standards of

- 24 Family Therapists and Professional Counselors shall promulgate
- 25 regulations to carry out this act within 180 days of the
