AN ACT

- 1 Providing for museum preservation and for grant program;
- 2 imposing duties on the Pennsylvania Historical and Museum
- Commission; establishing the Pennsylvania Museum Preservation
- 4 Fund; and making an appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Pennsylvania
- 9 Museum Preservation Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "AAM." The American Alliance of Museums.
- 15 "Accredited museum." A museum that has been accredited by
- 16 the American Alliance of Museums.
- 17 "Commission." The Pennsylvania Historical and Museum
- 18 Commission.

- 1 "Core documents." A mission statement, code of ethics,
- 2 strategic plan, disaster or emergency plan or collections
- 3 management policy.
- 4 "Eligible museum." A museum meeting the criteria for grants
- 5 under section 3.
- 6 "Fund." The Pennsylvania Museum Preservation Fund
- 7 established under section 4.
- 8 Section 3. Grant program.
- 9 (a) Establishment. -- The commission shall establish a program
- 10 to receive applications and award grants to eligible museums
- 11 pursuant to this act.
- 12 (b) Guidelines.--The commission shall establish guidelines
- 13 that are consistent with the provisions of this act within 120
- 14 days of the effective date of this act. The guidelines shall be
- 15 published in the Pennsylvania Bulletin and posted on the
- 16 Internet website of the commission.
- 17 (c) Program requirements.--
- 18 (1) An eligible museum is a museum in one of the
- 19 following categories:
- 20 (i) Botanic gardens and arboreta.
- 21 (ii) Children's museum.
- 22 (iii) A general museum with two or more equally
- 23 significant disciplines.
- 24 (iv) History museum.
- 25 (v) Historical society.
- 26 (vi) Historic house or site.
- 27 (vii) Military or maritime museum.
- 28 (viii) Natural history museum.
- 29 (ix) Nature center.
- 30 (x) Planetarium.

1 (xi) Science and technology center.

2 (xii) Multipurpose organization. An individual
3 museum within a multipurpose government or tax-exempt

4 organization may apply for a grant if the museum

5 functions as a discrete unit with the parent

organization. A museum that is part of a larger

7 organization must be deemed eligible if the museum:

- (A) has administrative autonomy for its operations;
- (B) has a fully segregated and itemized operating budget with the parent organization;
- (C) may separately and distinctly fulfill the eligibility and application requirements as defined in the guidelines established under subsection (b); and
- 16 (D) meets the AAM definition of a museum.
- 17 (2) Eligible museums must also meet the following standards:
- (i) Funds may only be distributed by the commission to eligible museums that commit to the AAM Pledge of Excellence.
- 22 (ii) The requirement under subparagraph (i) must be
 23 evidenced by the completion of core document verification
 24 with the AAM within two years of the effective date of
 25 this act.
- 26 (d) Grant limits.—The commission may award grants to an 27 eligible museum that meets the criteria of this section. The 28 grants may not exceed the following amounts:
- 29 (1) An eligible museum with an operating budget of more 30 than \$100,000 may apply for grants equal to 15% of their

- 1 operating budget.
- 2 (2) A museum with AAM accreditation may receive an
- additional grant of up to 1% of its operating budget.
- 4 (3) Grants, including additional grants under paragraph
- 5 (2), may not exceed \$500,000 in total for an eligible museum.
- 6 Section 4. Fund.
- 7 (a) Establishment.--There is hereby established in the State
- 8 Treasury a special fund to be known as the Pennsylvania Museum
- 9 Preservation Fund.
- 10 (b) Appropriation. -- Money in the fund is appropriated to the
- 11 commission for the purposes authorized under this act.
- 12 (c) Transfer.--The Commonwealth shall transfer 3.1% of the
- 13 funds collected by the realty transfer tax under Article XI-C of
- 14 the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform
- 15 Code of 1971, from the General Fund into the fund.
- 16 Section 20. Effective date.
- 17 This act shall take effect in 60 days.
