AN ACT

- 1 Reorganizing the Board of Trustees of The Pennsylvania State 2 University.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as The Pennsylvania
- 7 State University Board of Trustees Reorganization Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Board." The Board of Trustees of The Pennsylvania State
- 13 University.
- "Term of office." The term of years for which the Governor,
- 15 Lieutenant Governor, Attorney General, Auditor General or State
- 16 Treasurer is elected, or for which the president of the

- 1 university is appointed, irrespective of whether the individual
- 2 completes the term.
- 3 "University." The Pennsylvania State University established
- 4 under the act of February 22, 1855 (P.L.46, No.50), entitled "An
- 5 act to incorporate the Farmers' High School of Pennsylvania."
- 6 Section 3. Composition of board.
- 7 (a) Voting members.--Beginning January 1, 2015, the board
- 8 shall consist of 23 voting members as follows:
- 9 (1) Eight members who are alumni of the university and
- 10 elected by the alumni of the university in accordance with
- 11 the university charter.
- 12 (2) Five members appointed by the Governor, by and with
- the advice and consent of a majority of all members of the
- 14 Senate.
- 15 (3) Five members representing the Commonwealth's
- agriculture industry elected in accordance with the
- 17 university charter.
- 18 (4) Five members representing business and industry
- 19 endeavors appointed by the board and selected in accordance
- with section 4.
- 21 (b) Ex officio members. -- Beginning on the effective date of
- 22 this section, the Secretary of Agriculture and the Secretary of
- 23 Education, or their designees, shall serve on the board as
- 24 nonvoting, ex officio members of the board. The designee shall
- 25 be a deputy secretary or an equivalent position within the
- 26 agency.
- 27 (c) Changes to board composition. -- The General Assembly
- 28 shall have the sole and exclusive authority to determine the
- 29 composition of the board. Any changes to the composition of the
- 30 board may only be done through a duly enacted law of this

- 1 Commonwealth. Nothing in this act shall be construed to
- 2 authorize a change to the composition of the board through
- 3 amendment to the university charter, constitution or bylaws or
- 4 through court order or decree.
- 5 Section 4. Selection committee.
- The board shall establish a five-member selection committee
- 7 to review and recommend to the full board individuals to be
- 8 appointed to the board pursuant to section 3(a)(4). The
- 9 committee shall be comprised of:
- 10 (1) The chairman of the board.
- 11 (2) One member elected to the board pursuant to section
- 3(a)(1), selected by all members of the board elected
- pursuant to section 3(a)(1).
- 14 (3) One member appointed to the board pursuant to
- section 3(a)(2), selected by all members of the board
- appointed pursuant to section 3(a)(2).
- 17 (4) One member elected to the board pursuant to section
- 18 3(a)(3), selected by all members of the board elected
- 19 pursuant to section 3(a)(3).
- 20 (5) One member selected to the board pursuant to section
- 21 3(a)(4).
- 22 Section 5. Term of office.
- 23 The following shall apply:
- 24 (1) The term of office of a member elected pursuant to
- section 3(a)(1), (3) or (4) shall be three years.
- 26 (2) The term of office of a member appointed by the
- Governor pursuant to section 3(a)(2) shall be three years and
- until a successor is appointed and qualified. A member may
- 29 continue to hold office for a period not to exceed six months
- 30 beyond the expiration of that member's term if a successor to

- 1 that member has not been duly appointed and qualified
- 2 according to law.
- 3 Section 6. Vacancy.
- 4 (a) Gubernatorial appointments. -- An appointment to fill a
- 5 vacancy in the office of a member appointed by the Governor
- 6 pursuant to section 3(a)(2) shall be made within 60 days of the
- 7 vacancy and shall be for the remainder of the unexpired term.
- 8 (b) Other vacancies. -- A vacancy created in any office of a
- 9 member serving on the board pursuant to section 3(a)(1), (3) or
- 10 (4) shall be filled in the same manner as the original position
- 11 and in accordance with the university charter.
- 12 Section 7. Prohibitions.
- 13 (a) Public officials. -- Beginning on the effective date of
- 14 this act, the Governor, Lieutenant Governor, Attorney General,
- 15 Auditor General and State Treasurer shall be prohibited from
- 16 serving on the board during their terms of office.
- 17 (b) University president. -- Beginning on the effective date
- 18 of this act, the president of the university shall be prohibited
- 19 from serving on the board during the president's term of office.
- 20 Section 8. Status of board members.
- 21 The following shall apply to board members serving on the
- 22 effective date of this act:
- 23 (1) The Governor, the Secretary of the Department of
- 24 Conservation and Natural Resources and the president of the
- 25 university shall automatically be removed from the board on
- 26 the effective date of this act.
- 27 (2) Board members appointed by the Governor may, at the
- discretion of the Governor, continue to hold office as
- 29 members of the board for the term for which they were
- 30 appointed and, notwithstanding section 5(2), until their

- 1 successors are appointed and qualified.
- 2 (3) Board members representing the interests of business
- 3 and industry shall continue to hold office as members of the
- 4 board for the term for which they were elected.
- 5 (4) Board members representing the interests of
- 6 agriculture shall continue to hold office as members of the
- 7 board for the term for which they were elected.
- 8 (5) Board members representing the interests of alumni
- 9 shall continue to hold office as members of the board for the
- 10 term for which they were elected.
- 11 Section 9. 2014 appointments and elections.
- 12 Notwithstanding any other provision of law or any provision
- 13 of the university charter, constitution or bylaws to the
- 14 contrary, the following shall apply to elections or appointments
- 15 to the board in 2014:
- 16 (1) Two members shall be elected by the alumni.
- 17 (2) One member shall be elected by delegates
- 18 representing county agriculture societies.
- 19 (3) One member shall be selected pursuant to section 4.
- 20 (4) One member shall be appointed by the Governor in
- 21 accordance with law.
- 22 Section 10. Repeals.
- 23 All other acts or parts of acts are repealed insofar as they
- 24 are inconsistent with this act.
- 25 Section 11. Effective date.
- This act shall take effect immediately.
