A RESOLUTION

- Designating the month of March 2013 as "Problem Gambling Awareness Month" in Pennsylvania and observing the week of
- March 3 through 9, 2013, as "National Problem Gambling
- 4 Awareness Week."
- 5 WHEREAS, Individuals across the country and in this
- 6 Commonwealth enjoy the recreational aspects of legalized
- 7 gambling; and
- 8 WHEREAS, For some individuals and families, gambling becomes
- 9 an issue affecting and disrupting the lives of these individuals
- 10 and their families; and
- 11 WHEREAS, The National Council of Problem Gambling (NCPG)
- 12 reports that 2% to 3% of the United States population, which
- 13 equates to between six to nine million Americans, will have a
- 14 gambling problem in any given year; and
- WHEREAS, Problem gambling is a public health issue affecting
- 16 individuals of all ages, races and ethnic backgrounds in all
- 17 communities and having a significant societal and economic cost;
- 18 and

- 1 WHEREAS, Problem gambling is treatable, and treatment is
- 2 effective in minimizing the harm to individuals, families and
- 3 society as a whole; and
- 4 WHEREAS, Only a limited number of individuals affected by
- 5 problem gambling seek treatment options and utilize existing
- 6 problem gambling programs; and
- 7 WHEREAS, Numerous individuals, professionals and
- 8 organizations have dedicated their efforts to public awareness
- 9 of problem gambling and the availability and effectiveness of
- 10 treatment; and
- 11 WHEREAS, The NCPG is coordinating the Eleventh Annual
- 12 National Problem Gambling Awareness Week campaign during March 3
- 13 through 9, 2013, which seeks to educate the public about the
- 14 impact of problem gambling and the availability of treatment
- 15 options; therefore be it
- 16 RESOLVED, That the Senate designate the month of March 2013
- 17 as "Problem Gambling Awareness Month" in Pennsylvania and
- 18 observe the week of March 3 through 9, 2013, as "National
- 19 Problem Gambling Awareness Week"; and be it further
- 20 RESOLVED, That the Senate urge the Pennsylvania Gaming
- 21 Control Board to continue its outreach efforts and to work with
- 22 the Pennsylvania gaming industry to develop and implement
- 23 problem gambling programs and further promote community-based
- 24 programs in this Commonwealth; and be it further
- 25 RESOLVED, That the Senate urge the Department of Health in
- 26 conjunction with the Department of Drug and Alcohol Programs,
- 27 the Pennsylvania Gaming Control Board and individuals,
- 28 professionals and organizations dedicated to public awareness
- 29 and treatment of problem gambling to jointly create, develop and
- 30 promote public awareness campaigns regarding the recognition and

- 1 prevention of problem gambling; and be it further
- 2 RESOLVED, That the Senate urge all the citizens of this
- 3 Commonwealth to learn more about problem gambling and the
- 4 programs available to help individuals and their families who
- 5 have been adversely affected by this issue.
