- 1 Honoring the life and service of the Most Reverend Joseph P.
- 2 McFadden and expressing condolences on his death.
- 3 WHEREAS, The Senate mourns the loss of the Most Reverend
- 4 Joseph P. McFadden, the tenth Bishop of the Diocese of
- 5 Harrisburg, who passed away on May 2, 2013, at the age of 65;
- 6 and
- WHEREAS, Born in Philadelphia on May 22, 1947, Bishop
- 8 McFadden was the son of the late Thomas and Ellen Griffin
- 9 McFadden; and
- 10 WHEREAS, He attended St. Thomas More High School and
- 11 graduated from Saint Joseph University in 1969; and
- 12 WHEREAS, He entered Saint Charles Borromeo Seminary in 1976
- 13 and was ordained into the priesthood on May 16, 1981, by
- 14 Cardinal John Krol in the Cathedral Basilica of Saints Peter and

- 1 Paul; and
- 2 WHEREAS, Initially assigned as Parochial Vicar at St.
- 3 Laurence Parish in Highland Park, he was named Honorary Prelate
- 4 to His Holiness Pope John Paul II with the title of Monsignor on
- 5 May 29, 1991; and
- 6 WHEREAS, In 1993, Bishop McFadden was appointed the first
- 7 President of Cardinal O'Hara High School, and in 2001 he was
- 8 assigned as Pastor of Saint Joseph Parish; and
- 9 WHEREAS, Appointed Auxiliary Bishop of Philadelphia in June
- 10 2004, he was ordained to the Episcopacy on July 28, 2004; and
- 11 WHEREAS, Bishop McFadden was appointed the tenth Bishop of
- 12 Harrisburg by His Holiness Pope Benedict XVI on June 22, 2010,
- 13 and he was installed on August 18, 2010, at St. Patrick
- 14 Cathedral; and
- 15 WHEREAS, An advocate for Catholic education, he was President
- 16 of the Pennsylvania Catholic Conference, Chairman of the United
- 17 States Bishops' Committee on Catholic Education and a member of
- 18 the Board of Trustees at Saint Vincent Seminary; and
- 19 WHEREAS, Bishop McFadden represented many things to many
- 20 people, among them a beloved family member, dedicated religious
- 21 leader and avowed community steward who gave of his heart and
- 22 time to enhance the quality of life of his family, his community
- 23 and his congregations; therefore be it
- 24 RESOLVED, That the Senate note with great sadness the passing
- 25 of the Most Reverend Joseph P. McFadden, whose life greatly
- 26 benefited all those who lived, served and worked with him and
- 27 extend heartfelt condolences to his brother, John McFadden;
- 28 sisters, Jane McFadden and Ellen McConney; and many other family
- 29 members, friends, colleagues and parishioners; and be it further
