## AN ACT

9	Section 1. Section 1510 of Title 75 of the Pennsylvania
0	Consolidated Statutes is amended by adding a subsection to read:
1	§ 1510. Issuance and content of driver's license.

_3	(c.1) Autism spectrum disorder designation
4	(1) An individual who is diagnosed with an autism
. 5	spectrum disorder may request to have a notation of the
6	diagnosis placed on the individual's driver's license or
_7	identification card. The individual must present the
8 .	department with a sworn statement from a qualified medical
9	professional licensed in this Commonwealth verifying the

- 1 <u>diagnosis</u>. By submitting the request, the individual consents
- 2 <u>for the department to make public the diagnosis on the</u>
- 3 individual's driver's license or identification card.
- 4 (2) A parent or guardian of an individual under 18 years
- 5 <u>of age or under guardianship may request the notation</u>
- 6 provided under this subsection to be placed on the
- 7 individual's driver's license or identification card. The
- 8 parent or quardian must comply with all of the requirements
- 9 <u>under paragraph (1).</u>
- 10 (3) The department shall promulgate regulations
- 11 <u>necessary to administer this subsection.</u>

- 13 Section 2. Title 75 is amended by adding a section to read:
- 14 § 1521. Autism spectrum disorder awareness.
- 15 (a) Contributions. -- The department shall provide an
- 16 applicant for an original or renewal driver's license or
- 17 identification card the opportunity to make a contribution of \$1
- 18 to the Autism Spectrum Disorder Awareness Account established
- 19 under this section. The contribution shall be added to the
- 20 regular fee for an original or renewal driver's license or
- 21 identification card. One contribution may be made for each
- 22 issuance or renewal of a driver's license or identification
- 23 card. The department shall monthly determine the total amount
- 24 contributed under this section and shall report that amount to
- 25 the State Treasurer, who shall transfer that amount to the
- 26 Autism Spectrum Disorder Awareness Account.
- 27 (b) Account. -- The Autism Spectrum Disorder Awareness Account
- 28 is established as a restricted account within the General Fund.
- 29 Money in the account shall be appropriated on a continuing basis
- 30 to the Department of Health for education and training of

- 1 working professionals on autism spectrum disorder.
- 2 Section 3. This act shall take effect in 60 days.
