17	Section 1. (a) General ruleThe term "resident" or	

"residency," or any other term or expression used to designate a

19 Commonwealth resident student, when used to determine the rate

- 1 of tuition to be charged students attending community colleges,
- 2 PUBLIC INSTITUTIONS OF HIGHER LEARNING AND State-related and
- 3 State-owned institutions of higher learning shall be construed
- 4 to mean and include any <u>veterans</u>, their spouses and dependent
- 5 <u>children who do not currently reside in Pennsylvania. The term</u>
- 6 <u>shall also be construed to mean and include</u> military personnel
- 7 [or their dependents], their spouses and dependent children who
- 8 are assigned to an active duty station in Pennsylvania and who
- 9 reside in Pennsylvania and any civilian personnel [or their
- 10 dependents], their spouses and dependent children employed at a
- 11 Department of Defense facility who are transferred to
- 12 Pennsylvania by the Department of Defense and who reside in
- 13 Pennsylvania. [Military personnel and their dependents]
- 14 (a.1) PUBLIC INSTITUTIONS OF HIGHER LEARNING OR State-
- 15 <u>related or State-owned institutions.--Veterans, their spouses</u>
- 16 and dependent children, military personnel, their spouses and
- 17 <u>dependent children</u> and civilian personnel [and their
- 18 dependents], their spouses and dependent children who are
- 19 admitted to [a community college or] a PUBLIC INSTITUTION OF
- 20 HIGHER LEARNING OR A State-related or State-owned institution
- 21 shall be charged resident tuition rates provided that the
- 22 student is a resident under this section on the first day of the
- 23 semester or term of the [college or] institution.
- 24 (a.2) Community colleges. -- Veterans, their spouses and
- 25 <u>dependent children</u>, military personnel, their spouses and
- 26 <u>dependent children and civilian personnel</u>, their spouses and
- 27 <u>dependent children who are admitted to a community college shall</u>
- 28 be charged the local sponsor rate provided that the student is a
- 29 resident under this section on the first day of the semester or
- 30 <u>term of the college.</u>

- 1 (a.3) Distance learning tuition. -- A community college,
- 2 PUBLIC INSTITUTION OF HIGHER LEARNING OR State-related or State-<--
- 3 owned institution of higher learning [may] shall charge resident
- 4 tuition rates to any active military personnel and their
- 5 dependents who are taking college courses or receiving other
- 6 education services through the Internet or by other electronic
- 7 means.
- 8 (A.4) ELIGIBILITY.--A VETERAN AND HIS SPOUSE AND DEPENDENT <--
- 9 CHILDREN OR ANY OTHER INDIVIDUAL SHALL BE CHARGED A RESIDENT
- 10 TUITION RATE OR LOCAL SPONSOR RATE AS PROVIDED FOR UNDER THIS
- 11 ACT IF THE INDIVIDUAL IS ELIGIBLE TO RECEIVE BENEFITS UNDER ANY
- 12 OF THE FOLLOWING:
- 13 (1) 10 U.S.C. CHS. 1606 (RELATING TO EDUCATIONAL
- 14 <u>ASSISTANCE FOR MEMBERS OF THE SELECTED RESERVE) AND 1607</u>
- 15 (RELATING TO EDUCATIONAL ASSISTANCE FOR RESERVE COMPONENT
- 16 MEMBERS SUPPORTING CONTINGENCY OPERATIONS AND CERTAIN OTHER
- 17 OPERATIONS).
- 18 (2) 38 U.S.C. CH. 30 (RELATING TO ALL-VOLUNTEER FORCE
- 19 EDUCATIONAL ASSISTANCE PROGRAM).
- 20 (3) 38 U.S.C. CH. 31 (RELATING TO TRAINING AND
- 21 REHABILITATION FOR VETERANS WITH SERVICE-CONNECTED
- DISABILITIES).
- 23 (4) 38 U.S.C. CH. 33 (RELATING TO POST-9/11 EDUCATIONAL
- 24 ASSISTANCE).
- (a.4) (A.5) Additional eligibility.--A child, a spouse or a <--
- 26 surviving spouse who is eligible to receive benefits under 38
- 27 U.S.C. Ch. 35 (relating to survivors' and dependents'
- 28 educational assistance) shall also be charged a resident tuition
- 29 rate or local sponsor rate under the appropriate terms and
- 30 conditions of subsection (a.1), (a.2) or (a.3).

- 1 (b) Definitions.--As used in this section, the following
- 2 words and phrases shall have the meanings given them in this
- 3 subsection:
- 4 "Community colleges." Institutions now or hereafter created
- 5 pursuant to Article XIX-A of the act of March 10, 1949 (P.L.30,
- 6 No.14), known as the Public School Code of 1949, or the act of
- 7 August 24, 1963 (P.L.1132, No.484), known as the Community
- 8 College Act of 1963.
- 9 "Local sponsor." A school district, municipality or county
- 10 board of school directors, or any combination of school
- 11 districts, municipalities or county boards of school directors,
- 12 that participate or propose to participate in the establishment
- 13 <u>and operation of a community college.</u>
- 14 <u>"Local sponsor rate." The tuition charged to an individual</u>
- 15 who is a resident of a school district or municipality that is a
- 16 member of the local sponsor of the community college.
- 17 <u>"Member of a local sponsor." A school district or</u>
- 18 municipality that, alone or with other districts and
- 19 municipalities, is included in a local sponsor.
- 20 "PUBLIC INSTITUTION OF HIGHER LEARNING." A PUBLIC
- 21 <u>INSTITUTION LICENSED OR REGISTERED UNDER THE ACT OF DECEMBER 15,</u>

- 22 1986 (P.L.1585, NO.174), KNOWN AS THE PRIVATE LICENSED SCHOOLS
- 23 ACT, AND APPROVED TO OFFER A PROGRAM CULMINATING IN AN ASSOCIATE
- 24 IN SPECIALIZED BUSINESS DEGREE OR AN ASSOCIATE IN SPECIALIZED
- 25 TECHNOLOGY DEGREE.
- 26 "State-owned institutions." Those institutions which are
- 27 part of the State System of Higher Education pursuant to Article
- 28 XX-A of the act of March 10, 1949 (P.L.30, No.14), known as the
- 29 Public School Code of 1949.
- 30 "State-related institutions." The Pennsylvania State

- 1 University, the University of Pittsburgh, Temple University and
- 2 Lincoln University and their branch campuses.
- 3 "Veteran." An individual who served in the United States
- 4 Armed Forces, including a reserve component or National Guard
- 5 and who was discharged or released from service under conditions
- 6 other than dishonorable and is eligible to receive benefits <--
- 7 <u>under 10 U.S.C. Chs. 1606 (relating to educational assistance</u>
- 8 <u>for members of the selected reserve</u>) and 1607 (relating to
- 9 <u>educational assistance for reserve component members supporting</u>
- 10 contingency operations and certain other operations) and 38-
- 11 <u>U.S.C. Chs. 30 (relating to all-volunteer force educational</u>
- 12 <u>assistance program</u>), 31 (relating to training and rehabilitation
- 13 <u>for veterans with service-connected disabilities</u>) and 33
- 14 <u>(relating to post 9/11 educational assistance).</u> THE TERM <--
- 15 <u>INCLUDES AN INDIVIDUAL DESCRIBED IN 33 38 U.S.C. § 3319(B)</u>
- 16 (RELATING TO AUTHORITY TO TRANSFER UNUSED EDUCATION BENEFITS TO

- 18 Section 2. This act shall take effect immediately JULY 1, <--
- 19 2015, OR IMMEDIATELY, WHICHEVER IS LATER.
