AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, in professional and occupational
- licenses, further providing for definitions and for retention
- 4 and certification.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 7501 of Title 51 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 7501. [Definition] Definitions.
- 10 [As used in this chapter, the word "person" means any] The
- 11 following words and phrases when used in this chapter shall have
- 12 the meanings given to them in this section unless the context
- 13 clearly indicates otherwise:
- 14 "Person." An individual, whether male or female, who may,
- 15 have been, is now or may hereafter become engaged in the service
- 16 of the United States of America or its allies as a member of the
- 17 armed forces, or of the merchant marine thereof, or of any

- 1 auxiliary thereof subject to military discipline.
- 2 "Veteran." An individual who served on active duty in the
- 3 armed forces and who has been discharged or released from the
- 4 <u>service under conditions other than dishonorable.</u>
- 5 Section 2. Section 7502(b) of Title 51 is amended and the
- 6 section is amended by adding a subsection to read:
- 7 § 7502. Retention of licenses and certifications of persons
- 8 entering military service.
- 9 * * *
- 10 (b) Renewal of license or certification following
- 11 discharge.--[Any such person, upon presentation of a discharge
- 12 from such service within one year from date thereof, and upon
- 13 payment of the fee prescribed by law for the current renewal
- 14 period only, shall be entitled to a renewal of his or her
- 15 license, certification or registration in the same manner as
- 16 though such renewal had been made prior to the expiration of his
- 17 or her last preceding renewal, as though all intermediate
- 18 renewal fees had been paid and as though all continuing
- 19 education or in-service training requirements have been
- 20 satisfied.] A person shall, after presentation of a discharge
- 21 from service described under subsection (a) within one year from
- 22 the date of discharge and payment of the fee prescribed by law
- 23 for the current renewal period only, be entitled to a renewal of
- 24 his or her license, certification or registration in the same
- 25 manner as though:
- 26 <u>(1) The renewal had been made prior to the expiration of</u>
- 27 <u>his or her last preceding renewal.</u>
- 28 (2) All intermediate renewal fees had been paid.
- 29 (3) All continuing education or in-service training
- 30 requirements have been satisfied.

- 1 (c) Exemptions. -- A veteran's military service, education,
- 2 training and service experience shall be taken into
- 3 consideration by the entities listed under subsection (a) to
- 4 <u>determine whether a licensing or certification requirement has</u>
- 5 been met by or can otherwise be waived by reason of that
- 6 <u>military service</u>, <u>education</u>, <u>training or experience</u>. <u>The veteran</u>
- 7 <u>shall only be required to meet a licensing or certification</u>
- 8 requirement which has not been met by or waived under this
- 9 subsection.
- 10 Section 3. This act shall take effect in 60 days.
