AN ACT

- Amending the act of September 27, 1961 (P.L.1700, No.699), entitled "An act relating to the regulation of the practice
- of pharmacy, including the sales, use and distribution of 3
- drugs and devices at retail; and amending, revising, 4
- consolidating and repealing certain laws relating thereto,"
- further providing for the authority to administer injectable 6
- medications, biologicals and immunizations. 7
- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. Section 9.2 of the act of September 27, 1961
- 11 (P.L.1700, No.699), known as the Pharmacy Act, added June 29,
- 12 2002 (P.L.673, No.102), is amended to read:
- 13 Section 9.2. Authority to Administer Injectable Medications,
- 14 Biologicals and Immunizations .-- (a) [Within eighteen months
- 15 from the effective date of this section, the] The board shall by
- 16 regulation establish education and training standards and
- practice guidelines pursuant to which pharmacists shall be 17
- authorized to administer injectable medications, biologicals and 18

- 1 immunizations to persons who are more than eighteen years of age
- 2 <u>and influenza immunizations by injectable or needle-free</u>
- 3 <u>delivery methods to persons seven NINE years of age and older</u>. <--
- 4 Such standards and guidelines shall include, but not be limited
- 5 to, the following:
- 6 (1) Satisfactory completion of an academic and practical
- 7 curriculum approved by the board that includes the current
- 8 guidelines and recommendations of the Centers for Disease
- 9 Control and Prevention in the Public Health Service of the
- 10 United States Department of Health and Human Services, the
- 11 American Council on Pharmaceutical Education or a similar health
- 12 authority or professional body and includes, but is not limited
- 13 to, disease epidemiology, vaccine characteristics, injection
- 14 technique, emergency response to adverse events and related
- 15 topics.
- 16 (2) Maintenance of a current cardiopulmonary resuscitation
- 17 (CPR) certificate acceptable to the board.
- 18 (3) That the administration of injectable medications,
- 19 biologicals and immunizations be in accordance with a definitive
- 20 set of treatment guidelines established by a physician and, the
- 21 Centers for Disease Control and Prevention, Advisory Committee
- 22 on Immunization Practices quidelines or another competent
- 23 <u>authority</u> approved by the board.
- 24 (4) That a minimum of two hours of the thirty-hour
- 25 requirement for continuing education for license renewal be
- 26 dedicated to this area of practice.
- 27 <u>(5) For individuals under eighteen years of age, that</u>
- 28 parental consent be obtained prior to administration.
- 29 Administration of influenza immunizations by injectable or
- 30 needle-free delivery methods shall be in accordance with the

- 1 <u>immunization schedule established by the Centers for Disease</u>
- 2 Control and Prevention.
- 3 (6) Maintenance of a level of professional liability
- 4 <u>insurance coverage in the minimum amount of one million dollars</u>
- 5 (\$1,000,000) per occurrence or claims made. Failure to maintain
- 6 <u>insurance coverage as required shall subject the licensees to</u>
- 7 <u>disciplinary proceedings</u>. The board shall accept as satisfactory
- 8 evidence of insurance coverage any of the following:
- 9 <u>(i) personally purchased liability insurance;</u>
- 10 (ii) professional liability insurance coverage provided by
- 11 the individual licensee's employer; or
- 12 (iii) similar insurance coverage acceptable to the board.
- 13 (7) Notification of the individual's primary care provider,

- 14 <u>if known, within seventy two FORTY-EIGHT hours of</u>
- 15 administration.
- 16 (b) A pharmacist's authority to administer injectable
- 17 medications, biologicals and immunizations shall not be
- 18 delegated to any other person. A pharmacy intern who has
- 19 completed a course of education and training which meets the
- 20 requirements of subsection (a) (1) and (2) may administer
- 21 injectable medications, biologicals and immunizations to persons
- 22 who are more than eighteen years of age and influenza
- 23 immunizations by injectable or needle-free delivery methods to
- 24 persons seven NINE years of age and older only under the direct, <--
- 25 immediate and personal supervision of a pharmacist holding the
- 26 authority to administer injectable medications, biologicals and
- 27 immunizations.
- 28 Section 2. This act shall take effect in 60 days.
