AN ACT

Amending the act of December 22, 1983 (P.L.327, No.85), entitled, as amended, "An act imposing regulations and 2 licensing requirements on auctioneers, apprentice 3 auctioneers, auction houses, auction companies and trading assistants; imposing powers and duties on the State Board of Auctioneer Examiners; and making repeals," further providing for the title of the act, for definitions, AND for auctioneer <-- and apprentice auctioneer licenses; providing for sales 8 exempt from license requirements; further providing for 9 status of existing licensees and for applications for initial 10 and renewal licenses; providing for registration of trading 11 assistants and trading assistant companies; further providing 12 for special licensees to furnish bond and for authority to 13 transact business not transferable; repealing provisions 14 relating to auction house license, auction company license, 15 trading assistant registration and nonresident licensees; 16 further providing for reciprocity with other states; repealing provisions relating to licensee and registrant to 17 18 furnish bond; further providing for no other license or 19 20 registration required and for list of licensees and 21 registrants; providing for contracts; further providing for 22 records of sales; repealing provisions relating to contracts for conduct of transaction; and further providing for display of licenses, for investigations and enforcement actions, for 23 24 escrow account, for hearing on charges, for administration 25 and enforcement, for revocation or suspension of license or 26 27 registration, for issuance of new license or registration pending investigation and decision, for issuance of new 28

- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. The title and sections 2 and 3 of the act of
- 7 December 22, 1983 (P.L.327, No.85), known as the Auctioneer
- 8 Licensing and Trading Assistant Registration Act, amended
- 9 October 8, 2008 (P.L.1080, No.89), are amended to read:

- 16 Section 2. Definitions.
- 17 The following words and phrases when used in this act shall
- 18 have the meanings given to them in this section unless the
- 19 context clearly indicates otherwise:
- 20 "Apprentice auctioneer." [A person] An individual who is
- 21 licensed under this act as an apprentice auctioneer.
- 22 "Auction" or "sale at auction."
- 23 (1) [The offer to sell] for sale of property they an
- auctioneer or apprentice auctioneer to the members of an
- audience congregated for the purpose of making bids for the
- 26 purchase of the property through the solicitation of bids <--

- 27 <u>from one or more potential buyers</u> in an effort fby the
- 28 auctioneer or apprentice auctioneer to advance the amount of <--
- 29 the bids to obtain the highest or most favorable offer <--

- 31 METHOD FOR THE SALE OR LEASE OF PROPERTY, OR ANY INTEREST IN

3	OR A PHYSICAL GESTURE BETWEEN AN AUCTIONEER, APPRENTICE
4	AUCTIONEER OR AUCTION COMPANY AND ONE OR MORE POTENTIAL

8	(2) The term "auction" or "sale at auction" includes:
9	(i) live auctions;
10	(ii) online auctions;
11	(iii) real-time auctions;
12	(iv) extended auctions; and
13	(v) any similar such events as may be devised with
14	the development of technology, or otherwise involving the <
15	sale of property and the advancement of the price through
16	<u>a bidding process.; AND</u>
17	(VI) ANY COMBINATION OF THE FOREGOING.
18	(3) The term "auction" or "sale at auction" [excludes <
19	any sale conducted through an online {Internet bidding <
20	platform trading assistant consignment sale transaction.] <
21	DOES NOT INCLUDE A NEGOTIATED TRANSACTION. NOTHING IN THIS
22	ACT IS INTENDED TO DENY AN AUCTIONEER, APPRENTICE AUCTIONEER
23	OR AUCTION COMPANY A COMMISSION OR OTHER COMPENSATION EARNED
24	FOR AUCTION-RELATED ACTIVITIES THAT RESULT IN OR FACILITATE A
25	NEGOTIATED TRANSACTION BY THE SELLER OR OTHER AGENT OF THE
26	SELLER, AND A BUYER.
27	(4) The term "auction" or "sale at auction" shall not be <
28	limited by technology existing on the effective date of this
29	paragraph.
30	"Auction company." [A company which, as part of its

- 1 business, arranges, manages, sponsors, advertises or carries out
- 2 auctions.] A legally recognized entity that sells or attempts to
- 3 <u>sell property at auction or performs, or offers to perform, any</u>
- 4 of the functions or activities requiring licensure as an auction
- 5 company under section 3(a)(1). The term includes any legally
- 6 recognized entity that holds itself out as engaged in the
- 7 <u>business of selling property at auction.</u>
- 8 "Auction house." An established place of business,
- 9 including, but not limited to, an auction barn, a sale barn and
- 10 a sale pavilion, <u>used primarily for conducting auctions</u>, where
- 11 two or more auctions are held within any 12-month period and
- 12 where representations are regularly made that property is sold
- 13 at auction. The term does not include premises where isolated or
- 14 periodic sales are conducted by an auctioneer or auctioneer
- 15 apprentice and [which] that are used primarily for purposes
- 16 other than auctions or sales at auction.
- 17 "Auctioneer." [A person] An individual who sells or offers
- 18 or attempts to sell property at auction. The term includes [any
- 19 person who holds] an individual who:
- 20 (1) Engages in or offers the calling for and recognition
- of bids at auction.
- 22 (2) Engages in or offers any of the activities of an
- auction company.
- 24 (3) Performs, or offers to perform, any of the functions
- or activities requiring licensure under section 3(a)(1).
- 26 (4) Holds himself out as engaged in the business of
- 27 selling property at auction.
- 28 <u>"Auctioneer-of-record." The licensed auctioneer designated</u>
- 29 by an auction company as its auctioneer-of-record. The
- 30 <u>auctioneer-of-record</u> is principally responsible for the conduct

- 1 of the auctions of the auction company in accordance with this
- 2 act.
- 3 "Board." The State Board of Auctioneer Examiners [in the
- 4 Department of State].
- 5 "Commissioner." The Commissioner of Professional and
- 6 Occupational Affairs in the Department of State.
- 7 "Department." The Department of State.
- 8 <u>"Extended auction." An auction conducted in whole or in part</u>
- 9 <u>online at which bids are received over an extended period of</u>
- 10 time identified by a starting time and ending time that may
- 11 <u>encompass multiple minutes, hours, days or other periods.</u>
- 12 "Group A auction school." A provider, approved by the board,
- 13 offering a course of study in auctioneering and the auction
- 14 industry, as approved by the board, the completion of which
- 15 requires not less than 20 credit hours, including two credit
- 16 hours of practicum or cooperative practical experience.
- 17 <u>"Group B auction school." A provider, approved by the board,</u>
- 18 offering a course of study in auctioneering and the auction
- 19 industry, as approved by the board, the completion of which
- 20 requires fewer than 20 credit hours.
- 21 "Legally recognized entity." A partnership, association,
- 22 corporation, limited liability company or other entity
- 23 recognized under the laws of this Commonwealth or any other
- 24 state.
- 25 "Licensee." [A person licensed under this act including an
- 26 auctioneer, apprentice auctioneer, holder of a special license
- 27 and, in the case of an auction house or company, the person
- 28 required to obtain the license.] An individual licensed under
- 29 this act as an auctioneer, apprentice auctioneer or holder of a
- 30 special license and a legally recognized entity licensed under

- 1 this act as an auction company.
- 2 "Live auction." An auction or sale at auction at which one
- 3 or more members of an audience are present in person, are
- 4 <u>communicating telephonically or by other digital or electronic</u>
- 5 means or are participating by absentee bid.
- 6 "NEGOTIATED TRANSACTION." A TRANSACTION FOR THE SALE OF
- 7 PROPERTY, INVOLVING OFFERS AND COUNTEROFFERS, CONDUCTED THROUGH
- 8 A PROCESS OF NEGOTIATION BETWEEN THE PROSPECTIVE BUYER AND ANY
- 9 OF THE FOLLOWING:
- 10 (1) THE SELLER;
- 11 (2) THE SELLER'S AGENT; OR
- 12 <u>(3) OTHER INTERESTED PARTY.</u>
- 13 "Online auction." An auction or sale at auction conducted
- 14 <u>over the Internet or similar interactive communication media.</u>
- 15 ["Online Internet bidding platform." Hardware or software
- 16 architecture that provides or enables computer access by
- 17 multiple users to an interactive computer server for the purpose
- 18 of allowing users to offer property for sale and that does not
- 19 examine, set the price or prepare the description of the
- 20 property to be offered.]
- 21 "Online trading assistant consignment transaction." A
- 22 transaction pursuant to which a registrant or licensee describes
- 23 and lists personal property of another for sale through the use
- 24 of hardware or software that enables computer access by multiple
- 25 users to an interactive computer server:
- 26 (1) allowing individual sellers, and those acting on
- 27 <u>behalf of sellers, to list and offer the property for sale at</u>
- a set price, or best offer, or through competitive and
- 29 progressive offers that may include a buy-it-now feature; and
- 30 (2) allowing prospective buyers access to the hardware

- 1 <u>or software.</u>
- 2 "On-site auction." An auction or sale at auction conducted
- 3 at the seller's residential or business location where the
- 4 property to be sold is located.
- 5 "Person." An individual[, partnership, association,
- 6 corporation, limited liability company or other] or a legally
- 7 <u>recognized</u> entity.
- 8 "Property." Real and personal property, including both
- 9 tangible and intangible personal property. The term includes,
- 10 but is not limited to, domestic animals and farm products.
- "Qualified [auctioneer] sponsor." A currently licensed
- 12 auctioneer residing in this Commonwealth.
- 13 "Real-time auction." An auction or sale at auction at which
- 14 bids are solicited and received contemporaneously, in real time.
- 15 "Registrant." A person registered under this act as a
- 16 trading assistant or a trading assistant company.
- 17 <u>"Seller." The owner of property, or the legal representative</u>
- 18 or agent of the owner of property, who consigns or otherwise
- 19 agrees to have the property sold at auction or by way of an
- 20 online trading assistant consignment sale transaction.
- 21 "Special licensee." The holder of a special license issued
- 22 pursuant to section 3.
- 23 <u>"Temporary venue." A venue, including a rented hall, used</u>
- 24 primarily for other purposes, at which an auction or sale at
- 25 <u>auction is held by an auction company or an auctioneer,</u>
- 26 regardless of the frequency of the auctions or sales at auction.
- 27 "Trading assistant." An individual who, for a commission or
- 28 fee, conducts or intends to conduct a business within this
- 29 Commonwealth of [accepting personal property to sell on behalf
- 30 of another through an online Internet bidding platform.]

- 1 <u>selling</u>, or offering to sell, the personal property of another
- 2 through an online trading assistant consignment sale
- 3 transaction, or who performs, or offers to perform, any of the
- 4 <u>functions or activities requiring registration under section</u>
- 5 5.1(a).
- 6 "Trading assistant company." A legally recognized entity
- 7 that, for a commission or fee, conducts or intends to conduct a <--
- 8 <u>business within this Commonwealth of selling</u>, or offering to
- 9 <u>sell, the personal property of another through an online trading</u>
- 10 assistant consignment sale, or that performs, or offers to
- 11 perform, any of the functions or activities requiring
- 12 <u>registration under section 5.1(a).</u>
- 13 Section 3. Auctioneer [and], apprentice auctioneer, auctioneer
- 14 <u>company and special</u> licenses.
- 15 (a) Requirement for license. -- [Notwithstanding section 10.1,
- 16 it]
- 17 (1) It is unlawful for any person to engage in [or carry
- on] the <u>business</u> or profession of an auctioneer, apprentice
- 19 <u>auctioneer or an auction company</u> to conduct [a sale at] <u>an</u>
- auction, to hold himself out as an auctioneer or as an
- 21 apprentice auctioneer, to hold itself out as an auction
- 22 <u>company</u> or to offer to conduct [sales at auction] <u>auctions</u> in
- this Commonwealth without first obtaining [from the board] a
- license <u>from the board</u> as an auctioneer [or apprentice
- auctioneer. Any member, officer or employee of a partnership,
- association or corporation who attempts to sell at auction or
- 27 who is actively engaged in the auction profession must have a
- license as an auctioneer or apprentice auctioneer.],
- 29 apprentice auctioneer, auction company or special licensee.
- 30 (2) (i) Regardless of whether the computer system or

1	server utilized in connection with an online auction is
2	physically located within this Commonwealth, a license
3	shall be required for any person offering to conduct or
4	agreeing to conduct an online auction, or conducting an
5	<pre>online auction, if:</pre>
6	(A) the seller is situate in this Commonwealth
7	at the time the offer is made, the agreement is made
8	or the online auction is held;
9	(B) the online auction involves the sale of real
10	property situate in this Commonwealth; or
11	(C) the online auction involves the sale of
12	personal property situate in this Commonwealth at the
13	time the offer is made, the agreement is made or the
14	online auction is held.
15	(ii) Under this section, licensure is not required
16	under circumstances in which the seller initiates contact
17	with an auctioneer, auction company or other provider of
18	auction services located outside of this Commonwealth to
19	sell personal property at an online auction outside of
20	this Commonwealth.
21	(3) Any owner, member, officer, employee or independent
22	contractor retained by an auction company who calls bids or
23	engages in other activities requiring licensure under this
24	act must be licensed as an auctioneer or apprentice
25	auctioneer. Notwithstanding the foregoing, a license is not
26	required for an individual, acting as an agent or
27	representative of a licensee under this act, to negotiate or
28	execute contracts on behalf of the licensee.
29	(4) Licensees under this act shall be authorized to
30	conduct auctions at any venue within this Commonwealth,

- 1 <u>including on-site auctions and auctions held at auction</u>
- 2 <u>houses and temporary venues, and by any method of conducting</u>
- 3 the sale, including live auctions and online auctions and
- 4 <u>auctions that are conducted live and online</u>
- 5 contemporaneously, whether real-time auctions or extended
- 6 <u>auctions</u>.
- 7 [(b) Issuance and supervision of licenses.--It is the duty
- 8 of the board, upon payment of the license fees required and upon
- 9 compliance with the requirements of this act, to issue a license
- 10 as an auctioneer or apprentice auctioneer to individuals or as
- 11 an auctioneer to partnerships, associations and corporations who
- 12 qualify under and comply with this act. The board shall
- 13 supervise and control all licenses issued under this act.]
- (c) Qualifications in general for license.--[Licenses]
- 15 Auctioneer, apprentice auctioneer and special auctioneer
- 16 <u>licenses</u> shall be granted only to [persons] <u>individuals</u> who have
- 17 a good reputation for honesty, truthfulness, integrity and
- 18 competence to transact the business of an auctioneer or
- 19 apprentice auctioneer in a manner as to safeguard the interest
- 20 of the public and only after satisfactory proof of these
- 21 qualifications has been presented to the board as required by
- 22 this act and regulation.
- 23 (d) [Qualifications for apprentice] Apprentice auctioneer
- 24 license. -- To qualify for an apprentice auctioneer license, [a
- 25 person] an individual must be sponsored and employed for
- 26 compensation by a qualified [auctioneer] sponsor who employs no
- 27 more than one other apprentice auctioneer. As approved by the
- 28 board, an apprentice auctioneer may transfer his apprenticeship
- 29 to another qualified sponsor without forfeiting any qualifying
- 30 auctions previously completed in accordance with subsection (e)

- 1 (1).
- 2 (e) [Qualifications for auctioneer] <u>Auctioneer</u> license.--To
- 3 qualify for an auctioneer license, [a person] an individual must
- 4 have passed the prescribed examination after [having]:
- 5 (1) [served] <u>serving</u> an apprenticeship as a licensed
- 6 apprentice auctioneer for a period of not less than two years
- 7 in the employ of a qualified [auctioneer] sponsor and
- 8 [participated] <u>participating</u> for compensation in no less than
- 9 30 auctions[;], including auctions under the supervision of a
- 10 substitute qualified sponsor, without limitation as to the
- 11 method of conducting the auctions, which may include online
- 12 <u>auctions;</u> [or]
- 13 (2) successfully [completed] completing a prescribed
- course of study in auctioneering [of at least 20 credit hours
- at a school approved by the board.] at a Group A auction
- 16 school;
- 17 (3) successfully completing a prescribed course of study
- 18 <u>in auctioneering at a Group B auction school and served</u> <
- 19 SERVING an apprenticeship as a licensed apprentice auctioneer <--
- for a period of not less than one year in the employ of a
- 21 qualified sponsor, and participating for compensation in no <--
- less than 15 auctions, which may include auctions under the
- 23 supervision of a substitute qualified sponsor, without
- limitation as to the format of the auctions, which may
- 25 include online auctions;
- 26 (4) being licensed in good standing by another state to
- 27 <u>engage in auctioneering for at least two years. The board</u>
- shall review applications under this paragraph to determine
- 29 <u>the qualifications of the applicant; or</u>
- 30 (5) demonstrating that the individual has conducted

- 1 auctioneering for at least two years in a state that does not
- 2 require a license. The board shall review applications under
- 3 this paragraph to determine the qualifications of the
- 4 <u>applicant.</u>
- 5 <u>(e.1) Auction company license.--</u>
- 6 (1) Every legally recognized entity shall, before
- 7 operating as an auction company, obtain an auction company
- 8 license issued by the board.
- 9 (2) Every auction company shall designate an auctioneer-
- 10 of-record. Each auction company licensed under this act shall
- designate an individual licensed as an auctioneer under this
- 12 act to serve as the auction company's auctioneer-of-record.
- 13 The designation of the auctioneer-of-record shall be made in
- the initial application for licensure as an auction company
- and in each application for renewal of an auction company
- license. The auctioneer-of-record may be an owner,
- 17 shareholder, member, partner, employee, independent
- contractor or other agent of the auction company. The
- 19 auctioneer-of-record is principally responsible for the
- 20 conduct of the auctions of the auction company in accordance
- 21 with this act. However, nothing in this act shall limit or
- 22 restrict the ability of an auction company to utilize the
- 23 services of one or more auctioneers in addition to the
- 24 auctioneer identified as auctioneer-of-record, and it shall
- 25 not be necessary for the auctioneer-of-record to be present
- at every auction conducted by the auction company, provided
- 27 that a licensed auctioneer is present to conduct the
- activities required to be conducted by a licensed auctioneer
- 29 under this act. An auction company license becomes invalid if
- 30 the license of the auctioneer-of-record is not renewed or is

- 1 <u>suspended or revoked or if the auctioneer-of-record becomes</u>
- 2 <u>deceased or otherwise ceases to be the auction company's</u>
- 3 <u>auctioneer-of-record without substitution by a successor</u>
- 4 <u>auctioneer-of-record.</u>
- 5 (3) Within 30 calendar days after an auction company's
- 6 <u>auctioneer-of-record ceases to serve as auctioneer-of-record</u>
- for the auction company, both the auction company and the
- 8 <u>auctioneer-of-record or the auctioneer-of-record's legal</u>
- 9 <u>representative shall notify the board in writing of the</u>
- 10 <u>termination of such status.</u>
- 11 (f) [Qualifications for license reissued after long
- 12 inactivity] Reissuance of inactive license. -- Any [person]
- 13 <u>individual</u> to whom an auctioneer [or apprentice auctioneer]
- 14 license has been issued and [who has been inactive as an
- 15 auctioneer or apprentice auctioneer for a period of seven years
- 16 without renewing the license issued to him shall be required to
- 17 submit to and pass an examination approved by the board prior to
- 18 having a license reissued to him.] whose license has been in an_
- 19 inactive or nonrenewed status for a period of seven or more
- 20 years shall be required to submit to and pass an examination
- 21 approved by the board prior to having a license reissued. Any
- 22 individual to whom an apprentice auctioneer license has been
- 23 issued and whose license has been in an inactive or nonrenewed
- 24 status for a period of seven or more years shall be required to
- 25 make a new application to the board.
- 26 [(g) Designation of auctioneer-of-record.--If the applicant
- 27 for a license is a partnership, association or corporation, then
- 28 a member of the partnership or association or an officer of the
- 29 corporation, who is licensed in this Commonwealth as an
- 30 auctioneer, must be designated as the auctioneer-of-record. The

- 1 auctioneer-of-record is principally responsible for the conduct
- 2 of the auctions of the partnership, association or corporation
- 3 in accordance with this act. A partnership, association or
- 4 corporation auctioneer license becomes invalid if the license of
- 5 the auctioneer-of-record is not renewed or is suspended or
- 6 revoked.]
- 7 (q.1) Special license to conduct auction. -- An auctioneer or
- 8 <u>auction company authorized to engage in auctioneering in another</u>
- 9 state shall, on application and payment of the license fee, be
- 10 issued a special license for each specifically identified
- 11 auction to be conducted in this Commonwealth. Applications must
- 12 be made not less than 20 days in advance of the auction or sale
- 13 at auction and must include the name and address of the seller
- 14 or owner of all items to be sold. All applications are subject
- 15 to approval by the board and shall include proof of authority to
- 16 engage in auctioneering in the other state. This subsection does
- 17 not prohibit an auctioneer or auction company licensed in
- 18 another state from working or sharing compensation with a
- 19 <u>licensed Pennsylvania auctioneer or auction company in this</u>
- 20 Commonwealth with respect to an auction conducted pursuant to a
- 21 contract between the seller or owner of the property and an
- 22 auctioneer or auction company licensed in this Commonwealth and,
- 23 under such circumstances, a special license shall not be
- 24 required unless the out-of-State auctioneer will call bids or
- 25 engage in any other conduct that requires a license under this
- 26 act.
- [(h) Sales exempt from license requirements.--
- 28 The requirement to obtain a license under this act does not
- 29 apply to sales at auction in the following circumstances:
- 30 (1) To a specified single sale per year conducted by the

- 1 owner of property if the owner is not engaged in the business
- of selling the property and if the property is owned by the
- 3 person in an individual capacity.
- 4 (2) To a sale conducted by or on behalf of a charitable
- 5 organization if the person conducting the sale receives no
- 6 compensation therefor.
- 7 (3) To a sale conducted by or on behalf of a person
- 8 appointed by judicial order or decree.
- 9 (4) To a sale conducted in the settlement of any
- 10 decedent's estate.
- 11 (5) To a sale conducted by or under the direction of any
- 12 public authority.
- 13 (6) To any sale required by law to be at auction.
- 14 (i) Special license to conduct auction. -- An auctioneer
- 15 authorized to engage in auctioneering in another state shall,
- 16 upon application and payment of the license fee, be issued a
- 17 special license for each auction conducted by him. Applications
- 18 must be made 20 days in advance of the sale and must include the
- 19 name and address of the consignor or owner of all items to be
- 20 sold. All applications are subject to approval by the board and
- 21 shall include proof of authority to engage in auctioneering in
- 22 the other state.]
- 23 Section 2. The act is amended by adding a section to read:
- 24 Section 3.1. Sales exempt from license requirements.
- The requirement to obtain a license under this act does not
- 26 apply to sales at auction in the following circumstances:
- 27 <u>(1) To a specified single sale per year conducted by the</u>
- owner of property if the owner is not engaged in the business
