- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, in sentencing, further
- providing for sentences for offenses against elderly persons.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 9717 of Title 42 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding subsections to read:
- 8 § 9717. Sentences for offenses against elderly persons.
- 9 * * *
- 10 (a.1) Mandatory sentence for theft of prescription
- 11 medication. -- A person under 60 years of age convicted of the
- 12 <u>following offenses when the victim is over 60 years of age and</u>
- 13 the items taken, disposed of, deceived or extorted were
- 14 prescription medications shall be sentenced to a mandatory term
- 15 of imprisonment as follows:
- 16 <u>18 Pa.C.S. § 3921 (relating to theft by unlawful taking</u>
- 17 or disposition) not less than 12 months, but the imposition

- of the minimum sentence shall be discretionary with the court
- where the court finds justifiable cause and that finding is
- 3 written in the opinion.
- 4 <u>18 Pa.C.S. § 3922 not less than six months, but the</u>
- 5 <u>imposition of the minimum sentence shall be discretionary</u>
- 6 with the court where the court finds justifiable cause and
- 7 that finding is written in the opinion.
- 8 <u>18 Pa.C.S. § 3923 (relating to theft by extortion) not</u>
- 9 less than six months, but the imposition of the minimum
- sentence shall be discretionary with the court where the
- 11 court finds justifiable cause and that finding is written in
- 12 <u>the opinion.</u>
- 13 * * *
- 14 (c) Definition.--As used in this section, the term
- 15 "prescription medication" means a drug that is available only
- 16 with written instructions from a doctor to a pharmacist
- 17 prescribed for and intended to be used by one individual and
- 18 regulated by the Federal Food and Drug Administration.
- 19 Section 2. This act shall take effect in 60 days.
