AN ACT

- 1 Establishing the Adopt-a-River Program; providing for powers and
- duties of the Department of Conservation and Natural
- Resources; and making an appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Adopt-a-River
- 8 Act.
- 9 Section 2. Declaration of policy.
- 10 The General Assembly finds and declares as follows:
- 11 (1) Widespread flooding and damage caused by severe
- 12 winter storms greatly damage the riverbeds and streambeds of
- this Commonwealth. Flooding of urban and industrial areas
- often results in the pollution of rivers and the accumulation
- of extraordinary amounts of trash and debris in the
- 16 streambeds, on the stream banks and in floodplain areas.

- 1 (2) There is a heightened public awareness of
- 2 conservation and the need to protect the rivers of this
- 3 Commonwealth from pollution, damage, trash and debris and to
- 4 provide the resources necessary to restore Pennsylvania's
- 5 rivers and streams.
- 6 (3) The Pennsylvania Fish and Boat Commission personnel
- 7 and financial resources available for operation of its
- 8 existing Adopt-a-Stream Program are limited. The Pennsylvania
- 9 Fish and Boat Commission program is designed to expand fish
- 10 habitat, angling, boating and aesthetic values of
- 11 Commonwealth waters and would complement the Adopt-a-River
- 12 Act to be administered by the Department of Conservation and
- 13 Natural Resources.
- 14 Section 3. Definitions.
- The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 "Department." The Department of Conservation and Natural
- 19 Resources of the Commonwealth.
- 20 "Program." The Adopt-a-River Program established under this
- 21 act.
- 22 Section 4. Establishment of Adopt-a-River Program.
- 23 The department shall administer a program designed to remove
- 24 litter from and to beautify the rivers of this Commonwealth. The
- 25 program shall be known as the Adopt-a-River Program. The program
- 26 shall include public informational activities but shall be
- 27 directed primarily toward encouraging and facilitating
- 28 involvement of volunteer groups in litter cleanup work,
- 29 assigning each group to a specific river or stream segment.
- 30 Volunteer groups may include individuals, civic groups and

- 1 businesses.
- 2 Section 5. Agreements.
- 3 An agreement entered into between the department and a
- 4 volunteer group under section 4 shall include, but not be
- 5 limited to, the following criteria:
- 6 (1) The volunteer group may request a specific segment
- of the river or stream it wishes to adopt, but the assignment
- 8 shall be at the discretion of the department. In assigning
- 9 sections of a river, the department shall coordinate and
- 10 cooperate with affected Federal, State and local management
- agencies and private landowners. The department may require
- the volunteer groups to notify or obtain written permission
- to perform cleanup activities from landowners immediately
- 14 abutting the waterways.
- 15 (2) The group shall remove litter along the designated
- river or stream segment at least twice each year or as funds
- 17 permit and in a manner that is safe and appropriate for
- 18 members of the volunteer group.
- 19 (3) The group shall agree to abide by all rules related
- to the program that are adopted by the department.
- 21 (4) The volunteer group shall contract to care for the
- designated river or stream segment for at least two years.
- 23 Section 6. Department responsibilities.
- 24 (a) Distribution. -- The department shall ensure a wide and
- 25 diverse distribution of the funds, materials and information to
- 26 a variety of projects throughout this Commonwealth.
- 27 (b) Assistance. -- The department shall provide trash bags,
- 28 safety information and assistance to the participating volunteer
- 29 groups.
- 30 (c) Large and heavy items. -- The department shall be

- 1 responsible for facilitating contracts for the removal of large
- 2 or heavy items from a river or stream segment as deemed
- 3 necessary and feasible by the department. The department may
- 4 also use funds for tipping fees and disposal costs involved with
- 5 the removal of trash and debris.
- 6 (d) Private contributions. -- The department shall encourage
- 7 private contributions to the program to aid in implementing the
- 8 program to the fullest possible extent.
- 9 Section 7. Volunteer recognition.
- 10 The department shall create a recognition program to
- 11 acknowledge the efforts of volunteer groups, agencies and
- 12 businesses that participate in the program, which may include
- 13 appropriate signage in areas of high visibility that does not
- 14 detract from the natural beauty of the stream.
- 15 Section 8. Reporting requirement.
- 16 The department shall report annually to the General Assembly
- 17 on the implementation and progress of the program established by
- 18 this act.
- 19 Section 9. Regulations.
- 20 The department may adopt the regulations necessary for
- 21 implementation of the program.
- 22 Section 10. Appropriation.
- The sum of \$1,000,000, or as much thereof as may be
- 24 necessary, is appropriated to the Department of Conservation and
- 25 Natural Resources for the fiscal year July 1, 2015, to June 30,
- 26 2016, to carry out the provisions of this act.
- 27 Section 11. Effective date.
- This act shall take effect in 120 days.
