1 "City." A city of the <u>second class A or</u> third class with a 2 population of at least 30,000 based on the most recent Federal 3 decennial census. The term shall not include a city that has had 4 a receiver appointed under Chapter 7 of the act of July 10, 1987 5 (P.L.246, No.47), known as the Municipalities Financial Recovery 6 Act.
