## AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as reenacted, "An act relating to alcoholic liquors, alcohol and 2 malt and brewed beverages; amending, revising, consolidating 3 and changing the laws relating thereto; regulating and restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 7 8 persons engaged or employed therein; defining the powers and 9 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for responsible alcohol 17 18 19 management. 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 Section 1. Section 471.1 of the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, reenacted and amended 23 24 June 29, 1987 (P.L.32, No.14), is amended by adding a subsection 25 to read:
- 26 Section 471.1. Responsible Alcohol Management. --\* \* \*

- 1 (h) Unless successfully completed prior to being hired, all
- 2 <u>alcohol service personnel shall be required to complete the</u>
- 3 seller or server training under subsection (b) within sixty days
- 4 of being hired by a licensed establishment. The board shall
- 5 <u>certify private third-party providers of training under</u>
- 6 <u>subsection</u> (b) that covers, at a minimum, the content contained
- 7 in the Bureau of Alcohol Education's standard curriculum. In the
- 8 <u>event that the third-party provider's curriculum is not</u>
- 9 equivalent to the standard curriculum, the provider shall be
- 10 advised by the board as to where the curriculum is deficient.
- 11 The board shall permit private third-party providers of alcohol
- 12 training to modify the order in which the content of the Bureau
- 13 of Alcohol Education's standard curriculum is presented so long
- 14 <u>as the material is taught.</u>
- 15 Section 2. This act shall take effect in 60 days.
