1 2 3 4 5 6 7	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in preliminary provisions, further defining "emergency vehicle"; in operation of vehicles, further providing for drivers of emergency vehicles; and, in other required equipment, further providing for visual and audible signals on emergency vehicles and for visual signals on authorized vehicles.

10	Section 1. The definition of "emergency vehicle" in section
11	102 of Title 75 of the Pennsylvania Consolidated Statutes,
12	amended October 14, 2014 (P.L. 2491, No.140), is amended to

15	Subject to additional definitions contained in subsequent
16	provisions of this title which are applicable to specific
17	provisions of this title, the following words and phrases when
18	used in this title shall have, unless the context clearly
19	indicates otherwise, the meanings given to them in this section:

1 "Emergency vehicle." A State or county emergency management 2 vehicle, fire department vehicle, police vehicle, sheriff 3 vehicle, ambulance, advanced life support squad vehicle, basic life support squad vehicle, emergency canteen support service 4 organization vehicle, blood delivery vehicle, human organ 5 6 delivery vehicle, hazardous material response vehicle, armed 7 forces emergency vehicle, one vehicle operated by a coroner or 8 chief county medical examiner and one vehicle operated by a chief deputy coroner or deputy chief county medical examiner 9 10 used for answering emergency calls, a vehicle owned by or leased to a regional emergency medical services council that is used as 11 12 authorized by the Department of Health to respond to an actual or potential disaster, mass casualty situation or substantial 13 14 threat to public health, a vehicle owned by a county or regional 15 police association and operated by a police officer that is used 16 for police transport or victim extraction, <u>a vehicle that is</u> owned and operated by a county correctional institution in a 17 city of the first class and used to respond to an emergency at a 18 19 correctional institution in a city of the first class or to 20 escort an ambulance which is transporting sick or injured prisoners in a city of the first class, any vehicle operated by 21 a special agent, special agent supervisor, narcotics agent or 22 23 narcotics agent supervisor while performing official duties as 24 employees of the Office of Attorney General, any vehicle owned 25 and operated by the Philadelphia Parking Authority established 26 in accordance with 53 Pa.C.S. Ch. 55 (relating to parking authorities) and used in the enforcement of 53 Pa.C.S. Ch. 57 27 28 (relating to taxicabs and limousines in first class cities), a_ 29 vehicle owned and operated by the Pennsylvania Turnpike Commission that is used by an emergency service responder as 30

dispatched by the Pennsylvania Turnpike Commission's traffic 1 2 operations center, or any other vehicle designated by the State 3 Police under section 6106 (relating to designation of emergency vehicles by Pennsylvania State Police), or a privately owned 4 vehicle used in answering an emergency call when used by any of 5 6 the following: A police chief and assistant chief. 7 (1)8 (2)A fire chief, assistant chief and, when a fire company has three or more fire vehicles, a second or third 9 10 assistant chief. 11 A fire police captain and fire police lieutenant. (3) 12 An ambulance corps commander and assistant (4) 13 commander. 14 (5) A river rescue commander and assistant commander. 15 (6) A county emergency management coordinator. 16 (7)A fire marshal. Section 3105 of Title 75 is amended by adding a 22 subsection to read: 23 § 3105. Drivers of emergency vehicles. * * * 24 25 (d.1) Vehicles owned and operated by a county correctional 26 institution in a city of the first class. -- The driver of a vehicle that is owned and operated by a county correctional 27 institution in a city of the first class and used to respond to 28 29 an emergency at a correctional institution in a city of the first class or to escort an ambulance which is transporting a 30 20150HB0898PN1121

sick or injured prisoner in a city of the first class shall_ 1 comply with maximum speed limits, red signal indications and 2 3 stop signs. After ascertaining that the vehicle will be given the right-of-way, the driver may proceed through a red signal 4 indication or stop sign. 5 6 * * * Section 3. Section 4571(f) of Title 75 is amended and 7 8 subsection (b.1) is amended by adding a paragraph to read: 9 § 4571. Visual and audible signals on emergency vehicles. * * * 10 11 (b.1) Mounted lights and additional equipment. --* * * 12 13 (1.1) Nothing contained in the regulations under 14 paragraph (1) may be construed to require a limit, 15 modification or change of the lighting in police, sheriff and 16 fire vehicles legally complying with regulations as of the date of enactment of this paragraph as long as the vehicle is 17 18 used as an emergency vehicle. * * * 19 20 (f) Conformity with department regulations.--[All] Except as provided under subsection (b.1) (1.1), all equipment authorized 21 22 or required by this section shall conform to department 23 regulations. 24 Section 4. Section 4572(a) of Title 75 is amended by adding 25 a paragraph to read: § 4572. 3	(2.1) Nothing contained in the regulations under
4	paragraph (2) shall be construed to require a limit,
5	modification or change of the lighting in vehicles legally
6	complying with regulations as of the date of enactment of

10	Section 5. This act shall take effect in 60 days.
