16	Subject to additional definitions contained in subsequent	
17	provisions of this title which are applicable to specific	
18	provisions of this title, the following words and phrases when	
19	used in this title shall have, unless the context clearly	
20	indicates otherwise, the meanings given to them in this section:

- 7 delivery vehicle, hazardous material response vehicle, armed
- 8 forces emergency vehicle, one vehicle operated by a coroner or
- 9 chief county medical examiner and one vehicle operated by a
- 10 chief deputy coroner or deputy chief county medical examiner
- 11 used for answering emergency calls, a vehicle owned by or leased
- 12 to a regional emergency medical services council that is used as
- 13 authorized by the Department of Health to respond to an actual
- 14 or potential disaster, mass casualty situation or substantial
- 15 threat to public health, a vehicle owned by a county or regional
- 16 police association and operated by a police officer that is used
- 17 for police transport or victim extraction, a vehicle that is
- 18 owned and operated by a county correctional institution in a
- 19 city of the first class and used to respond to an emergency at a
- 20 correctional institution in a city of the first class or to
- 21 escort an ambulance which is transporting sick or injured
- 22 prisoners in a city of the first class, any vehicle operated by

- 27 § 3105. Drivers of emergency vehicles.

- 29 <u>(d.1) Vehicles owned and operated by a county correctional</u>
- 30 institution in a city of the first class. -- The driver of a

- 1 vehicle that is owned and operated by a county correctional
- 2 institution in a city of the first class and used to respond to
- 3 an emergency at a correctional institution in a city of the
- 4 <u>first class or to escort an ambulance which is transporting a</u>
- 5 <u>sick or injured prisoner in a city of the first class shall</u>
- 6 comply with maximum speed limits, red signal indications and
- 7 stop signs. After ascertaining that the vehicle will be given
- 8 the right-of-way, the driver may proceed through a red signal
- 9 <u>indication or stop sign.</u>

- 21 fire vehicles legally complying with regulations as of the
- 22 <u>date of enactment of this paragraph as long as the vehicle is</u>
- used as an emergency vehicle.

- 22 organization members and owners and handlers of dogs used in
- 23 tracking humans may each equip one motor vehicle with no more
- 24 than two flashing or revolving blue lights.

- 4 § 6119. REMOVAL OF DEAD DEER.
- 5 (A) DUTY.--IT IS THE DUTY OF THE DEPARTMENT TO REMOVE DEAD
- 6 DEER FROM THE STATE RIGHT-OF-WAY UPON IMMEDIATE NOTIFICATION AND
- 7 WHEN THE DEPARTMENT IS CONDUCTING GENERAL MAINTENANCE ON THE
- 8 STATE RIGHT-OF-WAY.
- 9 (B) NOTICE OF HAZARD.--THE DEPARTMENT SHALL ERECT SIGNS
- 10 STRATEGICALLY INFORMING THE PUBLIC OF DEER CROSSINGS AND PROVIDE
- 11 NOTICE TO THE PUBLIC ON WHEN DEER ARE MOST ACTIVE TO REDUCE THE
- 12 RISK OF A DEER-RELATED CRASH.
