## AN ACT

1 2 3	Designating a portion of State Route 2029 and 2049, also known as Bath Road, in Bristol Township, Bucks County, as the Sergeant George Stuckey Memorial Road.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Sergeant George Stuckey Memorial Road.
7	(a) Findings
8	(1) Sergeant George F. Stuckey was born June 29, 1939,
9	in Michigan and came to the Bucks County area when he was a
10	child. He was a graduate of Delhaas High School.
11	(2) Sergeant Stuckey was a police officer with the
12	Bristol Township Police Department where he served for seven
13	years. He held the rank of detective for five years before
14	becoming acting sergeant in the detective division. He served
15	as the department's photographic expert.

1 (3) Sergeant Stuckey made the ultimate sacrifice on 2 March 29, 1972, when he was shot and killed in the line of 3 duty while stopping a vehicle involved in a bank robbery 4 along Bath Road in Bristol Township. The shooting occurred 5 only a couple hundred feet from the police headquarters.

6 (4) Sergeant Stuckey was the first police officer in
7 Bucks County to be killed in the line of duty.

8 (b) Designation.--The section of State Route 2029, known as 9 Bath Road, that runs between US Route 13 (Segment 10) to Oxford 10 Valley Road (Segment 40) and the section of State Route 2049, 11 also known as Bath Road, that runs between Oxford Valley Road 12 (Segment 10) to State Route 413 (Segment 40) in Bristol 13 Township, Bucks County, are hereby designated as the Sergeant 14 George Stuckey Memorial Road.

15 (c) Signs.--The Department of Transportation shall erect and 16 maintain appropriate signs displaying the name of the highway to 17 traffic in both directions on the highway.

18 Section 2. Effective date.

19 This act shall take effect in 60 days.
