AN ACT

- 1 Establishing the Results First Project; and providing for data 2 collection and analysis by the Independent Fiscal Office.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Results First
- 7 Act.
- 8 Section 2. Legislative intent and purpose.
- 9 The General Assembly finds and declares that a nationally
- 10 recognized cost-benefit analysis model will allow the General
- 11 Assembly to direct public resources to cost-effective programs
- 12 that deliver the best outcomes for residents. The Independent
- 13 Fiscal Office shall receive periodic updates that incorporate
- 14 new research and enhancements identified through work in
- 15 participating states and practical technical assistance to
- 16 implement this cutting-edge approach for identifying policy and
- 17 budget options. Through this effort, Pennsylvania will lay the

- 1 groundwork for a strong evidence-based approach that will
- 2 identify the State government's vision, mission, philosophy,
- 3 priority goals and benchmarks. The General Assembly will help
- 4 State agencies to align the State agency's individual efforts
- 5 and resources to achieve Statewide priority outcomes.
- 6 Section 3. Definitions.

- 30 Section 4. Duties.

- 1 (a) Development. -- Within one year of the effective date of
- 2 this section, the Independent Fiscal Office shall implement and
- 3 maintain the Pennsylvania Results First Project.
- 4 (b) Consultation. -- The Independent Fiscal Office shall
- 5 consult with a nationally recognized organization that
- 6 specializes in and has expertise with the scientific basis of a
- 7 cost-benefit analysis model.
- 8 (c) Reporting. -- The Independent Fiscal Office shall provide
- 9 reports as directed by the General Assembly by joint resolution.
- 10 Section 5. Data.
- 11 (a) Collection. -- Subject to any applicable limitation
- 12 provided by law, a data source shall submit, upon request of the
- 13 Independent Fiscal Office, data required for use as provided by
- 14 this act.
- 15 (b) Duty.--Data sources identified by the Independent Fiscal <--

- 17 (1) DATA SOURCES IDENTIFIED BY THE INDEPENDENT FISCAL
- 18 Office shall comply with the criteria established by the
- 19 Independent Fiscal Office and satisfy requirements deemed
- 20 necessary by the Independent Fiscal Office in order to
- 21 provide data.
- 22 (2) THE INDEPENDENT FISCAL OFFICE SHALL WORK
- 23 COLLABORATIVELY WITH DATA SOURCES AS NECESSARY TO ENSURE THAT

- 24 THE DATA PROVIDED IS OF APPROPRIATE CONTENT AND CONFORMS TO
- 25 PRACTICABLE FORMAT SPECIFICATIONS. DATA REQUIREMENTS OF THE
- 26 INDEPENDENT FISCAL OFFICE SHALL TAKE INTO ACCOUNT WORK FLOW
- 27 REQUIREMENTS OF DATA SOURCES.
- 28 (C) RESULTS.--A DATA SOURCE MAY NOT BE CHARGED A FEE TO
- 29 RECEIVE THE RESULTS GENERATED FROM DATA IT SUBMITS UNDER THIS
- 30 SECTION.

- 1 Section 6. Effective date.
- 2 This act shall take effect immediately.
