- (b) Plaques.--

2 (1) The department shall arrange for the fabrication of 3 [nine] appropriate bronze plaques in honor of veterans of the 4 following:

5	(i) The American Revolutionary War.		
6	(ii) The War of 1812.		
7	(iii) The Mexican-American War.		
8	(iv) The American Civil War.		
9	(v) The Spanish-American War.		
10	(vi) World War I.		
11	(vii) World War II.		
12	(viii) The Korean War.		
13	(ix) The Vietnam Conflict.		
14	(x) Any war or armed conflict officially engaged in		
15	by the United States commencing after the Vietnam		
16	<u>Conflict.</u>		
17	(2) The department shall also arrange for the		
18	fabrication of an appropriate bronze plaque to honor the		
19	unknown veterans of the wars and conflicts enumerated in		
20	paragraph (1).

22	(d) Medal of Honor MemorialThe Department of General		
23	Services shall arrange for the placement of permanent low-lying		
24	decorative chain barriers within the Medal of Honor Memorial		
25	Gardens at the end of each concrete arc representing the Tides		
26	<u>of War.</u>		
27	(e) SignageThe Department of General Services shall		
28	arrange to have signs placed conspicuously around "Soldiers'		
29	Grove" reminding people to respect the hallowed grounds of the		
30	Medal of Honor Memorial Gardens. The signs should read as

4	Section 2. The act is amended by adding sections to read:
5	Section 4.1. Preservation of "Soldiers' Grove."
6	The Department of General Services shall arrange for the
7	appropriate preservation of "Soldiers' Grove" as provided for in
8	the report issued pursuant to House Resolution 331 adopted June
9	21, 2011. Specifically, the Department of General Services shall
10	utilize the third recommendation contained on page 18 of the
11	report relating to the concept of erecting "Pillars of Time."
12	Section 4.2. Construction.
13	Nothing in this act shall be construed to limit the authority
14	of the Department of General Services to comply with the
15	provisions of this act while conforming to the original design
16	of the Medal of Honor Memorial Gardens to the greatest extent
17	possible.
18	Section 3. This act shall take effect immediately.
