AN ACT

Amending the act of June 1, 1945 (P.L.1242, No.428), entitled "An act relating to roads, streets, highways and bridges; 2 amending, revising, consolidating and changing the laws 3 administered by the Secretary of Highways and by the 4 Department of Highways relating thereto," providing for 5 commemorative designations; and making editorial changes. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. The title and section 102(3) and (4) of the act of June 1, 1945 (P.L.1242, No.428), known as the State Highway 10 11 Law, are amended to read: 12 AN ACT Relating to roads, streets, highways and bridges; amending, 13 14 revising, consolidating and changing the laws administered by the Secretary of [Highways] Transportation and by the 15 16 Department of [Highways] Transportation relating thereto. 17 Section 102. Definitions .-- When used in this act, the 18 following words and phrases shall have the following meanings: * * * 19 20 (3) "Department" shall mean the Department of [Highways]

- 2 (4) "Secretary" shall mean the Secretary of [Highways]
- 3 Transportation of the Commonwealth.
- 4 Section 2. The act is amended by adding a section to read:
- 5 <u>Section 204.1. Commemorative Designations.--The naming of a</u>
- 6 State-owned road or bridge to commemorate an individual or group
- 7 shall not require an act of the General Assembly, but shall be
- 8 at the discretion of the secretary, provided the following
- 9 <u>criteria are met:</u>
- 10 (1) Any individual, organization or political subdivision
- 11 requesting the commemorative designation must have a sponsor
- 12 <u>within the General Assembly who supports the designation</u>
- 13 <u>request.</u>
- 14 (2) Except as set forth in paragraph (3):
- (i) An individual, organization or political subdivision
- 16 requesting the commemorative designation must obtain a minimum
- 17 of one hundred (100) signatures of Commonwealth residents on a
- 18 petition and submit that petition to the department.
- 19 (ii) An individual in whose name a State-owned road or
- 20 bridge is to be designated must be deceased for at least two
- 21 years prior to the designation request.
- 22 (iii) The individual, organization or political subdivision
- 23 requesting or sponsoring the designation request must pay the
- 24 department in full for the cost of erecting and maintaining the
- 25 signs displaying the commemorative designation.
- 26 (3) The provisions of paragraph (2) do not apply to a
- 27 <u>commemorative designation for any of the following:</u>
- 28 (i) A member of the military who was killed in action during
- 29 a period of war or armed conflict.
- 30 (ii) Law enforcement personnel killed in the line of duty.

- 1 (iii) An emergency responder killed in the line of duty.
- 2 (4) The department shall pay the costs of erecting and
- 3 <u>maintaining signs for commemorative designations under paragraph</u>
- 4 (3).
- 5 Section 3. This act shall take effect in 60 days.
