Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in size, weight and load, further providing for 2 registered gross weight; and, in fees, providing for 3 recreational trailers. 4 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 7 Section 1. Title 75 of the Pennsylvania Consolidated Statutes is amended by adding a section to read: 8 § 1920.1. Recreational trailers. (a) General rule. -- The annual fee for registration of a 10 11 recreational trailer shall be determined by its registered gross 12 weight according to the following table: 13 Registered Gross 14 Weight in Pounds Fee 15 8,000 or less \$12 16 8,001 - 13,000 35 17 90 13,001 or more (b) Optional five-year registration. -- A recreational trailer 18

with a registered gross weight of 13,000 pounds or less may be

- 3 (c) Optional permanent registration. -- The following apply:
- 4 (1) A recreational trailer with a registered gross
- 5 weight of 13,001 or more pounds may be registered for a one-
- 6 <u>time fee of \$425 in lieu of the annual fee at the option of</u>
- 7 <u>the registrant.</u>
- 8 (2) A permanent registration of a recreational trailer
- 9 under this section may be transferred to another recreational
- trailer one time upon payment of the fee under section 1927
- 11 <u>(relating to transfer of registration).</u>
- 12 Section 2. Section 4942(c) of Title 75 is amended to read:
- 13 § 4942. Registered gross weight.

- 15 (c) Combination. -- No combination containing a trailer having
- 16 a gross weight or registered gross weight in excess of 10,000
- 17 pounds shall be operated with a gross weight in excess of the
- 18 registered gross weight of the truck or truck tractor for a
- 19 combination. This subsection shall not apply to a combination of
- 20 <u>vehicles consisting of a motor vehicle towing a recreational</u>
- 21 trailer as long as the combination weight does not exceed the
- 22 maximum combination weight rating of the towing vehicle as
- 23 specified by the vehicle manufacturer.
- 24 Section 3. This act shall take effect in 60 days.
