A JOINT RESOLUTION

1 2	Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, further providing for absentee voting.
3	The General Assembly of the Commonwealth of Pennsylvania
4	hereby resolves as follows:
5	Section 1. The following amendment to the Constitution of
6	Pennsylvania is proposed in accordance with Article XI:
7	That section 14 of Article VII be amended to read:
8	§ 14. Absentee voting.
9	(a) The Legislature shall, by general law, provide a manner
10	in which, and the time and place at which, [qualified electors
11	who may, on the occurrence of any election, be absent from the
12	municipality of their residence, because their duties,
13	occupation or business require them to be elsewhere or who, on
14	the occurrence of any election, are unable to attend at their
15	proper polling places because of illness or physical disability
16	or who will not attend a polling place because of the observance

of a religious holiday or who cannot vote because of election day duties, in the case of a county employee,] <u>any qualified</u> <u>elector</u> may vote <u>by absentee ballot</u>, and for the return and canvass of their votes in the election district in which they respectively reside.

6 [(b) For purposes of this section, "municipality" means a 7 city, borough, incorporated town, township or any similar 8 general purpose unit of government which may be created by the 9 General Assembly.]

10 Section 2. (a) Upon the first passage by the General Assembly of this proposed constitutional amendment, the 11 12 Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article 13 14 XI of the Constitution of Pennsylvania and shall transmit the 15 required advertisements to two newspapers in every county in 16 which such newspapers are published in sufficient time after passage of this proposed constitutional amendment. 17

18 (b) Upon the second passage by the General Assembly of this proposed constitutional amendment, the Secretary of the 19 20 Commonwealth shall proceed immediately to comply with the 21 advertising requirements of section 1 of Article XI of the 22 Constitution of Pennsylvania and shall transmit the required 23 advertisements to two newspapers in every county in which such 24 newspapers are published in sufficient time after passage of 25 this proposed constitutional amendment. The Secretary of the 26 Commonwealth shall submit this proposed constitutional amendment 27 to the qualified electors of this Commonwealth at the first primary, general or municipal election which meets the 28 requirements of and is in conformance with section 1 of Article 29 30 XI of the Constitution of Pennsylvania and which occurs at least
