AN ACT

- Providing for a grant program for a Statewide 2-1-1 system and imposing duties on the Department of Health.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Statewide 2-
- 7 1-1 System Grant Program Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Department." The Department of Health of the Commonwealth.
- 13 "Program." The Statewide 2-1-1 System Grant Program
- 14 established by this act.
- "Statewide 2-1-1 system." A communication system that
- 16 provides health and human service assistance, through the

- 1 dissemination of information about applicable programs and
- 2 services provided by government and private and nonprofit
- 3 organizations in local communities, to residents throughout this
- 4 Commonwealth using the three-digit dialing code of 2-1-1.
- 5 Section 3. Statewide 2-1-1 System Grant Program.
- 6 (a) Establishment.--The Statewide 2-1-1 System Grant Program
- 7 is established in the department. The purpose of the program
- 8 shall be to provide a grant to a qualified applicant for the
- 9 development, implementation, operation and support of a
- 10 Statewide 2-1-1 system, from funds appropriated or made
- 11 available to the department for that purpose.
- 12 (b) Duty of department.--The department shall, in
- 13 consultation with the Department of Human Services, develop and
- 14 implement a procedure to award a grant to a qualified applicant
- 15 for a Statewide 2-1-1 system. The grant shall be used for the
- 16 following purposes:
- 17 (1) To provide Statewide 2-1-1 system services 24 hours
- 18 each day throughout this Commonwealth, including to regions
- 19 of this Commonwealth that do not have access to a provider of
- 20 2-1-1 system services as of the effective date of this
- 21 section.
- 22 (2) To expand access to 2-1-1 system services and the
- 23 database to a 2-1-1 system through text-to-chat, mobile
- 24 application and a publicly accessible Internet website.
- 25 (3) To permit the disbursement of funds, with the
- 26 approval of the department, to regional providers of 2-1-1
- 27 system services for satisfying 2-1-1 quality assurance
- standards used by similar programs in other states.
- 29 (4) For any other purpose deemed appropriate by the
- 30 department for carrying out the provisions of this act.

- 1 Section 4. Effective date.
- 2 This act shall take effect in 60 days.
