1 2 3 4 5 6 7 8 9 10 11 22 3 14 15 16 17 18 9 20	To the act of November 30, 1965 (P.L.843, No.355), entitled "An act providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; providing for public support and capital improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University," making an appropriation for carrying the same into effect; providing for a basis for payments of such appropriation; and providing a method of accounting for the funds appropriated and for certain fiscal information disclosure.
21	The General Assembly of the Commonwealth of Pennsylvania
22	hereby enacts as follows:
23	Section 1. The following sum, or as much thereof as may be
24	necessary, is hereby appropriated to the Trustees of Temple

Section 2. Payments to Temple University on account of the appropriation provided in section 1 shall be made on the basis of costs during the fiscal year.

5 Section 3. (a) Payment to Temple University of the 6 appropriation provided in section 1 shall be made monthly during 7 the fiscal year.

8 (b) Such monthly payments shall be made in accordance with 9 the provisions of section 2 on the basis of estimated costs. The 10 estimate of costs shall be submitted by Temple University to the 11 Secretary of Education, the General Assembly and the State 12 Treasurer not later than 30 days prior to the date on which such 13 payment is to be made.

14 Section 4. (a) Temple University shall apply the moneys 15 appropriated by this act only for such purposes as are permitted 16 in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 120 days 17 18 after the close of the fiscal year to which this act relates, 19 Temple University shall file, with the Secretary of Education, 20 the General Assembly and the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes 21 of all expenditures made from moneys appropriated by this act 22 23 and other university accounts during said fiscal year, as 24 provided in section 2, used as a basis for receipt of any 25 appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered

and paid by Temple University to the State Treasurer. In respect 1 2 to expenditures made by the university from moneys other than 3 those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the 4 General Assembly such information concerning said expenditures 5 as the General Assembly or any of its committees may require. 6 7 Section 5. Temple University shall provide full, complete 8 and accurate information as may be required by the Department of Education or the chairman or the minority chairman of the 9 10 Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House 11 12 of Representatives.

13 Section 6. Temple University shall present and report its 14 financial statements required under the provisions of this act 15 in accordance with: the generally accepted accounting principles 16 as prescribed by the National Association of College and 17 University Business Officers, the American Institute of 18 Certified Public Accountants, or their successors, or by any 19 other recognized authoritative body; the "Commonwealth of 20 Pennsylvania Budget Instructions for the State System of Higher 21 Education, State-Related Universities and Non-State-Related Colleges and Universities"; and the financial reporting policies 22 23 and standards promulgated by the Commonwealth of Pennsylvania 24 and by the Federal Government that apply to Temple University. 25 Section 7. This act shall take effect July 1, 2016, or 26 immediately, whichever is later.
