AN ACT

Amending the act of March 29, 1803 (P.L.542, No.156), entitled 1 "An act to establish a Board of Wardens for the port of 2 Philadelphia, and for the regulation of pilots and pilotages, 3 and for other purposes therein mentioned," further providing 5 for fees. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 37 of the act of March 29, 1803 (P.L.542, No.156), entitled "An act to establish a Board of Wardens for 10 the port of Philadelphia, and for the regulation of pilots and 11 pilotages, and for other purposes therein mentioned," added June 23, 1993 (P.L.114, No.27), is amended to read: 12 13 Section 37. (a) All pilots, upon being issued an original license or upon renewal thereof, shall pay to the Navigation 14 15 Commission a fee [to be fixed by the Navigation Commission by 16 regulation but not to exceed {two hundred fifty] OF four hundred <--17 dollars[,]. INCREASES TO THE FEE SHALL BE FIXED BY THE <--NAVIGATION COMMISSION BY REGULATION BUT SHALL NOT EXCEED FIVE 18

HUNDRED TWENTY-FIVE DOLLARS, which shall be subject to review in

- 1 accordance with the act of June 25, 1982 (P.L.633, No.181),
- 2 known as the "Regulatory Review Act." If the projected revenues
- 3 to be generated by fees, fines and civil penalties imposed under
- 4 this act are not sufficient to match expenditures over the
- 5 renewal period, the Navigation Commission shall increase the
- 6 fees by regulation, subject to review under the "Regulatory
- 7 Review Act," so that the projected revenues will meet or exceed
- 8 projected expenditures: Provided, however, That the total amount
- 9 of any such fee may not exceed five hundred and twenty-five
- 10 <u>dollars annually</u>.
- 11 (b) If the Bureau of Professional and Occupational Affairs
- 12 determines that the fees established by the Navigation
- 13 Commission are inadequate to meet the minimum enforcement
- 14 efforts required, the Bureau of Professional and Occupational
- 15 Affairs, after consultation with the Navigation Commission,
- 16 shall increase the fees by regulation subject to review under
- 17 the "Regulatory Review Act" so that adequate revenue is raised
- 18 to meet the required enforcement effort[.]: Provided, however,
- 19 That the total amount of any such fee may not exceed five
- 20 hundred and twenty-five dollars annually.
- 21 Section 2. This act shall take effect in 60 days.
