AN ACT

- 1 Designating a bridge on that portion of State Route 741 over the
- 2 Conestoga River, between Pequea Township and Lancaster
- Township, Lancaster County, as the Corporal Eric M. Torbert,
- 4 Jr., Memorial Bridge.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Corporal Eric M. Torbert, Jr., Memorial Bridge.
- 8 (a) Findings.--The General Assembly finds and declares as
- 9 follows:
- 10 (1) Corporal Eric M. Torbert, Jr., was a 2003 graduate
- of Penn Manor High School.
- 12 (2) Cpl. Torbert enlisted with the United States Marine
- Corps on September 5, 2007, and served as a combat engineer
- 14 assigned to the 1st Combat Engineer Battalion, 1st Marine
- 15 Division, 1st Marine Expeditionary Force, based at Camp
- 16 Pendleton, California.

- 1 (3) On December 18, 2010, Cpl. Torbert valiantly gave
- 2 his life in service to his country while conducting combat
- 3 operations in Helmand Province, Afghanistan.
- 4 (4) Cpl. Torbert's personal service awards include the
- 5 Purple Heart, Combat Action Ribbon, National Defense Service
- 6 Medal and Sea Service Deployment Ribbon.
- 7 (b) Designation.--The bridge located on State Route 741 over
- 8 the Conestoga River, between Pequea Township and Lancaster
- 9 Township, Lancaster County, is hereby designated the Corporal
- 10 Eric M. Torbert, Jr., Memorial Bridge.
- 11 (c) Signs. -- The Department of Transportation shall erect and
- 12 maintain appropriate signs displaying the name of the bridge to
- 13 traffic in both directions on the bridge.
- 14 Section 2. Effective date.
- This act shall take effect in 60 days.
