## A RESOLUTION

1 2	Recognizing January 11, 2015, as "National Human Trafficking Awareness Day" in Pennsylvania.
3	WHEREAS, This Commonwealth has a tradition of advancing
4	fundamental human rights; and
5	WHEREAS, It is imperative to eliminate human trafficking,
6	including early or forced marriage, commercial sexual
7	exploitation, forced labor, labor obtained through debt bondage,
8	involuntary servitude, slavery and slavery by descent; and
9	WHEREAS, To combat human trafficking in this Commonwealth and
10	globally, Pennsylvania residents and State and local governments
11	must be aware of the realities of human trafficking and
12	dedicated to stopping this contemporary manifestation of
13	slavery; and

1 WHEREAS, Efforts must be made to actively oppose all 2 individuals, groups, organizations and nations who support, 3 advance or commit acts of human trafficking and to work to end human trafficking around the world through education; and 4 WHEREAS, Victims of human trafficking need support in order 5 6 to escape and to recover from the physical, mental, emotional 7 and spiritual trauma associated with their victimization; and 8 WHEREAS, Human traffickers use many physical and psychological techniques to control their victims, including the 9 10 use of violence or threats of violence against the victim or the victim's family, isolation from the public, isolation from the 11 12 victim's family and religious or ethnic communities, language 13 and cultural barriers, shame, control of the victim's possessions, confiscation of passports and other identification 14 15 documents and threats of arrest, deportation or imprisonment if 16 the victim attempts to reach out for assistance or leave; and 17 WHEREAS, Although laws to prosecute perpetrators of human 18 trafficking and to assist and protect victims of human 19 trafficking have been enacted in the United States, awareness of 20 the issues surrounding human trafficking by those people most likely to come into contact with victims is essential for 21 effective enforcement because the techniques that traffickers 22 23 use to keep their victims enslaved severely limit self-24 reporting; and

25 WHEREAS, The effort by individuals, businesses, organizations 26 and governing bodies to promote the observance of National Human 27 Trafficking Awareness Day on January 11 of each year represents 28 one of the many examples of the ongoing commitment to raise 29 awareness of and to actively oppose human trafficking; therefore 30 be it
