A RESOLUTION

- Designating the month of January 2015 as "National Blood Donor Month" in Pennsylvania.
- 3 WHEREAS, January has been recognized as National Blood Donor
- 4 Month for over 40 years; and
- 5 WHEREAS, Blood donors are an integral part of the health
- 6 system and national public health preparedness initiatives in
- 7 the United States; and
- 8 WHEREAS, Donating blood is a safe, lifesaving and selfless
- 9 gift that enhances the level of preparedness for each and every
- 10 community in this nation; and
- 11 WHEREAS, Donating one unit of blood saves as many as three
- 12 lives; and
- 13 WHEREAS, Blood and blood products are critical national

- 1 resources and vital public health assets that must be readily
- 2 available at all times; and
- 3 WHEREAS, According to the Department of Health, every two
- 4 seconds a person in the United States needs blood for lifesaving
- 5 treatment in an emergency or a disaster, a routine surgery or a
- 6 blood transfusion to help treat a serious disease like cancer or
- 7 an organ or bone marrow transplant; and
- 8 WHEREAS, A total of 30 million blood components are used in
- 9 transfusions every year in the United States; and
- 10 WHEREAS, One in seven patients who enter a hospital in the
- 11 United States needs blood; and
- 12 WHEREAS, For this reason, according to the American Red
- 13 Cross, more than 44,000 blood donations are needed every day;
- 14 and
- 15 WHEREAS, According to the Department of Health, approximately
- 16 60% of the Unites States population is eligible to give blood,
- 17 but only 5% of the eligible population donates blood on an
- 18 annual basis; and
- 19 WHEREAS, It is vital that the blood donation policies,
- 20 including donor deferral policies, in the United States keep
- 21 pace with medical science to ensure that our communities and our
- 22 country as a whole have a robust, eligible population of donors
- 23 to maintain a safe and adequate blood supply; and
- 24 WHEREAS, America's Blood Centers, the American Association of
- 25 Blood Banks and the American Red Cross support and perform
- 26 critical services collecting, processing and distributing
- 27 lifesaving blood and blood products to hospitals and health
- 28 providers and are instrumental in ensuring the safety of the
- 29 blood supply and promoting the need for blood donations;
- 30 therefore be it

- 1 RESOLVED, That the House of Representatives designate the
- 2 month of January 2015 as "National Blood Donor Month" in
- 3 Pennsylvania and encourage the residents of this Commonwealth to
- 4 contribute to the blood supply by donating and organizing or
- 5 volunteering at a blood drive or by suggesting blood donation to
- 6 their families and friends.
