## A RESOLUTION

1 2 3	Urging the Department of Transportation to update its regulation on the documentation required for a name change to a driver's license or identification card.
4	WHEREAS, The Department of Transportation has an established
5	policy as to the type of identification required for a change of
6	name to a driver's license or identification card; and
7	WHEREAS, An individual who adopts the surname of her THE <
8	INDIVIDUAL'S spouse is only required to provide a copy of the
9	couple's marriage certificate to obtain a change of name on her <
10	A noncommercial driver's license or AN identification card; and <
11	WHEREAS, In contrast, an individual who adopts the surname of
12	her THE INDIVIDUAL'S spouse and retains her THE INDIVIDUAL'S <
13	former surname as a middle name must provide a copy of the
14	individual's Social Security card, together with copies of
15	documents from two other sources issued in the desired name,
16	such as tax records, Selective Service card, voter registration
17	card, passport, photo identification issued by a governmental

- 2 WHEREAS, Individuals who retain their former surnames find it
- 3 difficult to obtain the additional required documentation; and
- 4 WHEREAS, Requiring this additional documentation constitutes
- 5 an unfair and unreasonable practice by the Department of
- 6 Transportation; therefore be it
- 7 RESOLVED, That the House of Representatives urge the
- 8 Department of Transportation to update its regulation which
- 9 requires difficult-to-obtain documentation to effect a change of
- 10 name to the driver's license or identification card of an
