A RESOLUTION

- Designating the month of April 2015 as "Alcohol Awareness Month" in Pennsylvania.
- 3 WHEREAS, Responsible consumption of alcohol by adults over 21
- 4 years of age and a zero-tolerance stance for alcohol use by
- 5 underage youths is vital to maintaining a healthy and
- 6 responsible citizenry; and
- WHEREAS, Alcohol use by young people is dangerous because of
- 8 the risks associated with acute impairment and the threat to
- 9 long-term development and well-being; and
- 10 WHEREAS, It is illegal to serve alcohol to a minor or a
- 11 visibly intoxicated patron at any retail operation or
- 12 establishment licensed to sell alcoholic beverages; and
- 13 WHEREAS, Anyone found guilty of providing alcohol to minors
- 14 or visibly intoxicated patrons faces various penalties,
- 15 including an immediate suspension or revocation of the license

- 1 or an imposed fine of not less than \$1,000 and no more than
- 2 \$5,000; and
- 3 WHEREAS, Adults in the community have the authority and
- 4 responsibility to provide minors with alternative opportunities
- 5 by creating alcohol-free activities; and
- 6 WHEREAS, The Pennsylvania beer industry and its beer
- 7 wholesale distributors promote responsible drinking by providing
- 8 the public and their retail accounts with education and
- 9 responsibility measures to ensure that no underage youth has
- 10 access to the product; and
- 11 WHEREAS, The Commonwealth encourages residents to refuse to
- 12 provide alcoholic beverages to underage youths and to take the
- 13 necessary steps to discourage the illegal and unhealthy practice
- 14 of underage drinking, including reporting to local police;
- 15 therefore be it
- 16 RESOLVED, That the House of Representatives discourage the
- 17 use of alcohol by persons below the legal age of consumption and
- 18 exhort all residents of this Commonwealth to refuse to provide
- 19 alcoholic beverages to underage youths and to continue to take
- 20 the necessary steps to discourage this illegal and unhealthy
- 21 activity; and be it further
- 22 RESOLVED, That the House of Representatives designate the
- 23 month of April 2015 as "Alcohol Awareness Month" in
- 24 Pennsylvania.
