A RESOLUTION

- 1 Appointing a committee and empowering it to make investigation.
- 2 RESOLVED, By the House of Representatives of the General
- 3 Assembly of the Commonwealth of Pennsylvania, that the Judiciary
- 4 Committee be authorized to investigate the conduct of the
- 5 Honorable Kelly S. Ballentine, a Magisterial District Judge for
- 6 Lancaster County, to determine whether Kelly S. Ballentine is
- 7 liable to impeachment for misbehavior in office and to report to
- 8 the House the conclusions of the committee in respect to the
- 9 investigation and determination with its appropriate
- 10 recommendations; and be it further
- 11 RESOLVED, That the Judiciary Committee shall designate the
- 12 Subcommittee on Courts to take testimony, review documents or
- 13 other materials and interview witnesses for the use of the
- 14 Judiciary Committee. The Subcommittee on Courts is authorized
- 15 and empowered to:
- 16 (1) make recommendations to the Judiciary Committee and

- 1 in the performance of its duties;
- 2 (2) send for persons and papers and subpoena witnesses,
- documents, and other materials under the seal of the
- 4 Subcommittee Chairman;
- 5 (3) administer oaths to witnesses;
- 6 (4) take testimony; and
- 7 (5) prepare and file pleadings and other legal
- 8 documents;
- 9 and be it further
- 10 RESOLVED, That upon receipt of the recommendations of the
- 11 Subcommittee on Courts, the Judiciary Committee be authorized
- 12 and empowered to:
- 13 (1) send for persons and papers and subpoena witnesses,
- documents and other materials under the hand and seal of the
- 15 chairman;
- 16 (2) administer oaths to witnesses;
- 17 (3) take testimony;
- 18 (4) prepare and file pleadings and other legal
- 19 documents; and
- 20 (5) employ staff;
- 21 and be it further
- 22 RESOLVED, That a sergeant-at-arms or his deputy shall serve
- 23 the process of the Judiciary Committee and Subcommittee on
- 24 Courts and execute its orders. The Judiciary Committee and
- 25 Subcommittee on Courts are authorized to sit during the sessions
- 26 of this House. The expenses of the investigation shall be paid
- 27 out of an appropriate account of the Chief Clerk, except that if
- 28 any staff expenses or compensation are to be paid by the Chief
- 29 Clerk, the approval of the Bipartisan Management Committee shall
- 30 be required.
