A RESOLUTION

1 2	Commemorating the 175th anniversary of the incorporation of the Borough of Monaca, Beaver County.
3	WHEREAS, The Borough of Monaca, Beaver County, borders the
4	Ohio River and is located 25 miles northwest of Pittsburgh; and
5	WHEREAS, The land now known as Monaca was first settled by
6	Native American members of the Iroquois Confederacy; and
7	WHEREAS, According to survey records from 1769, a 330-acre
8	tract of land, now part of Monaca, was first recorded by
9	colonists under the name of Smith Township; and
10	WHEREAS, According to records from April 15, 1785, this same
11	330-acre tract of land was surveyed by William L. Lungan, who
12	named the tract of land Appetite; and
13	WHEREAS, On September 5, 1787, Appetite was first purchased
14	through a patent from the Commonwealth for 42 pounds, 7
15	shillings and 6 pence by Ephraim Blaine, grandfather of American
16	statesman James G. Blaine; and
17	WHEREAS, On June 17, 1801, Appetite was sold and purchased by
18	Robert Callender, who died soon after and willed the land to

John Wilkens, Jr., George Wallace and Alexander Addison; and
WHEREAS, On December 29, 1804, Appetite was sold and
purchased by John Niblow; and

WHEREAS, On August 1, 1813, Appetite was sold and purchased by Frances Helvidi, a Polish nobleman who was exiled from his native country and immigrated to America and is said to be the first colonial settler of Appetite; and

8 WHEREAS, On August 30, 1821, Appetite was auctioned at a 9 public sale and won by Frederick Rapp; and

10 WHEREAS, On April 24, 1831, Appetite was sold and purchased 11 by Steven Phillips, the owner of the Phillips and Graham boat 12 yards; and

WHEREAS, On July 21, 1832, a group of settlers known as the New Philadelphia Society, led by Count Maximillian de Leon, purchased 800 acres of land, including Appetite, to develop a community called Phillipsburg, named after Steven Phillips, by constructing 50 houses, a hotel, factories and a stone church; and

WHEREAS, On March 6, 1840, the Municipal Government of Monaca was first incorporated under the name of Phillipsburg; and WHEREAS, In 1848, Dr. Edward Acker established the Water Cure Sanatorium in Phillipsburg which used hydrotherapy to perform medical treatment and is considered the first hospital in Beaver County; and

25 WHEREAS, Thiel College, then known as Thiel Hall, was founded 26 in 1866 by William A. Passavant in Phillipsburg and then 27 relocated to Greenville in 1870; and

28 WHEREAS, On September 20, 1892, the name of the borough was 29 changed from Phillipsburg to Monaca, in honor of Native American 30 Oneida Chief Monacatootha, who also served as a representative

of the Iroquois Confederacy and supported George Washington
during the American Revolutionary War; and

3 WHEREAS, Monaca's official flag was designed by a 7th grade 4 student named Tammi Temple and adopted by the borough council in 5 1976; and

6 WHEREAS, On July 1, 2009, the Center Area and Monaca school 7 districts merged to establish the Central Valley School 8 District, which was the first voluntary merger of public school 9 districts in this Commonwealth; and

10 WHEREAS, Due to its large natural deposits of fire clay, the 11 borough's manufacturers have produced enameled porcelain ware, 12 glass, tile, tubing, drawn steel and wire throughout its 13 history; and

14 WHEREAS, Today, the Borough of Monaca is home to more than 15 5,500 people; and

16 WHEREAS, During the week of June 20, 2015, the residents of 17 Monaca will observe the 175th anniversary of the borough's 18 incorporation by holding a series of celebratory events, which 19 will culminate with the Monaca 175th Anniversary Festival on 20 June 27, 2015; therefore be it

21 RESOLVED, That the House of Representatives commemorate the 22 175th anniversary of the incorporation of the Borough of Monaca, 23 Beaver County; and be it further

RESOLVED, That a copy of this resolution be transmitted to Mayor John P. Antoline and Council President John DiMarzio of the Borough of Monaca.
