A RESOLUTION

- 1 Memorializing Congress to examine existing Federal laws relating 2 to sober living arrangements.
- 3 WHEREAS, People with alcohol and other drug addictions may be
- 4 in need of a supportive, sober housing arrangements after
- 5 completing inpatient treatment for addiction; and
- 6 WHEREAS, Stable housing has been recognized as a verifiable
- 7 need for individuals in recovery, especially early recovery, but
- 8 is often difficult to obtain; and
- 9 WHEREAS, The goal is to find a place that is safe,
- 10 appropriately maintained and beneficial to the client's recovery
- 11 process; and
- 12 WHEREAS, Sober living recovery houses can be extremely
- 13 helpful in stabilizing early recovery as a person who is
- 14 addicted continues treatment and begins to search for
- 15 employment; and
- 16 WHEREAS, Congress added protections for persons with
- 17 disabilities to the Fair Housing Act of 1968 under the Fair

- 1 Housing Amendments Act of 1988; and
- 2 WHEREAS, These Federal statutes prohibit a broad range of
- 3 practices that discriminate against individuals on the basis of

- 4 race, color, religion, sex, national origin, familial status
- 5 and, handicap or disability OR HAVING A SUBSTANCE ABUSE
- 6 DISORDER; and
- 7 WHEREAS, The Americans with Disabilities Act (ADA) defines
- 8 disability; and
- 9 WHEREAS, The ADA requires public accommodation as well as
- 10 reasonable employer accommodation for persons with disabilities,
- 11 except when the accommodation would cause an undue hardship,
- 12 result in an undue burden or fundamentally alter the operation
- 13 of the business; and
- 14 WHEREAS, The Fair Housing Act as amended does not preempt
- 15 local zoning laws but is intended to prohibit the use of local
- 16 laws and ordinances to make housing unavailable to persons with
- 17 a disability solely on the basis of their disability; and
- 18 WHEREAS, Local governments must be sure to adhere to the
- 19 reasonable accommodation provisions of Federal law when enacting
- 20 changes to zoning ordinances or considering variance requests
- 21 from individuals with disabilities or their designees; and
- 22 WHEREAS, A certain percentage of Housing and Urban-
- 23 Development-funded housing dollars should be set aside for-
- 24 recovery housing; therefore be it
- 25 RESOLVED, That the House of Representatives of the
- 26 Commonwealth of Pennsylvania memorialize Congress to examine
- 27 existing Federal laws relating to sober living arrangements; and
- 28 be it further
- 29 RESOLVED, THAT A CERTAIN PERCENTAGE OF HOUSING AND URBAN
- 30 DEVELOPMENT-FUNDED HOUSING DOLLARS SHOULD BE SET ASIDE FOR

- 1 RECOVERY HOUSING; AND BE IT FURTHER
- 2 RESOLVED, That the examination note the impact of existing
- 3 laws on individuals in recovery and on communities; and be it
- 4 further
- 5 RESOLVED, That, when taxpayer dollars fund recovery housing,
- 6 the public be entitled to insist that certain minimal standards
- 7 be met in order to optimize the prospects for continued recovery
- 8 and for the health, safety and best interests of the public
- 9 client; and be it further
- 10 RESOLVED, That sober recovery houses be an essential element
- 11 of recovery support services, along with recovery community
- 12 centers, peer recovery specialists and recovery coaches, all
- 13 designed to acknowledge the many pathways to recovery and to
- 14 support long-term recovery from addiction; and be it further
- 15 RESOLVED, That copies of this resolution be transmitted to
- 16 the presiding officers of each house of Congress and to each
- 17 member of Congress from Pennsylvania.
