A RESOLUTION

- 1 Urging the Pennsylvania delegation to the 114th Congress of the 2 United States to support the passage of the Toxic Exposure 3 Research Act of 2015.
- 4 WHEREAS, The Toxic Exposure Research Act of 2015, introduced
- 5 as H.R. 1769, establishes a national center for research on the
- 6 diagnosis and treatment of health conditions of the descendants
- 7 of veterans exposed to toxic substances during their service
- 8 within the United States Department of Veterans Affairs and
- 9 creates an advisory board to oversee and assess the work of the
- 10 center; and
- 11 WHEREAS, Over the years, millions have served our great
- 12 nation in the United States Armed Forces and during their
- 13 service many have been exposed to toxins with unknown
- 14 consequences; and
- 15 WHEREAS, Most of these veterans did not know they were
- 16 exposed to harmful materials and many of these veterans suffered
- 17 from the harmful effects of these toxins; and

- 1 WHEREAS, Many children and grandchildren of veterans were
- 2 born with both structural and nonstructural defects and some
- 3 have been accepted into treatment programs by the United States
- 4 Department of Veterans Affairs as a result of exposure to toxins
- 5 from a parent's military service; and
- 6 WHEREAS, Birth anomalies in the children of veterans are not
- 7 tracked, mostly going unexplained and unreported; and
- 8 WHEREAS, While these anomalies have some similarities, more
- 9 research is needed on their causes; and
- 10 WHEREAS, Most states that have birth registries do not report
- 11 to a national registry and even infant deaths and birth defects
- 12 at military hospitals relating to the children of veterans are
- 13 not put into a Federal registry; and
- 14 WHEREAS, The United States Department of Veterans Affairs and
- 15 the United States Department of Defense have been tracking toxic
- 16 exposures and possible toxic exposures without follow-up
- 17 research on the veterans and their offspring; and
- 18 WHEREAS, The Toxic Exposure Research Act of 2015 would
- 19 require the Secretary of Veterans Affairs and the Secretary of
- 20 Defense to share data regarding toxic exposures; and
- 21 WHEREAS, Parents of children with birth defects carry a heavy
- 22 emotional and financial burden; and
- 23 WHEREAS, Veterans exposed to Agent Orange and its dioxin
- 24 contaminants have reported a variety of serious health problems
- 25 and symptoms, including cancers and birth defects in their
- 26 children; and
- 27 WHEREAS, The number of Vietnam veterans who have children and
- 28 grandchildren with birth defects related to exposure to Agent
- 29 Orange are significant and the planned research seeks to provide
- 30 diagnosis, treatment and care and focus on dependents; and

- 1 WHEREAS, In addition to creating a national center for
- 2 research, the Toxic Exposure Research Act of 2015 creates a
- 3 database of birth defects and anomalies, both structural and
- 4 nonstructural; and
- 5 WHEREAS, The Federal legislation is supported by the Vietnam
- 6 Veterans of America; and
- 7 WHEREAS, The Toxic Exposure Research Act of 2015 is not only
- 8 focused on research of Agent Orange and other chemicals used in
- 9 South Vietnam, but also exposures to chemical agents for all
- 10 veterans who served in our armed forces, including those exposed
- 11 to toxic fumes released by the United States Demolition
- 12 Operations at the Khamisiyah Pit and those exposed to toxic
- 13 fires from burn pits across Iraq and Afghanistan during
- 14 operation Enduring Freedom, Operation Iraqi Freedom and
- 15 Operation New Dawn; therefore be it
- 16 RESOLVED, That the House of Representatives of the
- 17 Commonwealth of Pennsylvania urge the Pennsylvania delegation to
- 18 the 114th Congress of the United States to support the passage
- 19 of the Toxic Exposure Research Act of 2015, H.R. 1769; and be it
- 20 further
- 21 RESOLVED, That copies of this resolution be transmitted to
- 22 the President of the United States, the United States Department
- 23 of Defense, the United States Department of Veterans Affairs and
- 24 to each member of Congress from Pennsylvania; and be it further
