1 Honoring Alexis A. Brown, Comptroller of the House of
2 Representatives, who is retiring in March 2016 after 41 years
3 of service to this Commonwealth.

4 WHEREAS, The House of Representatives expresses its gratitude
5 to Alexis A. Brown for her exemplary public service; and

6 WHEREAS, Ms. Brown has provided resolute leadership and
7 service as an officer of the House of Representatives since her
8 1997 selection and confirmation as Comptroller; and

9 WHEREAS, As Comptroller, Ms. Brown has served the House of
10 Representatives as its Chief Fiscal Officer; and

11 WHEREAS, Ms. Brown, in her role as Comptroller, was
12 instrumental in the development of the Legislative Financial
13 System, the Travel Expense System and the Legislative Payroll
14 System that is currently utilized by all members of the House of
15 Representatives and staff; and

1 WHEREAS, A 1974 graduate of Cedar Cliff High School, Ms.
2 Brown has been employed by the House of Representatives since
3 1989; and

4 WHEREAS, Ms. Brown's prior work on behalf of the General
5 Assembly and the residents of this Commonwealth included serving
6 in a variety of positions with the Legislative Data Processing
7 Center, the Office of the Chief Clerk of the House of
8 Representatives and the Bipartisan Management Committee; and

9 WHEREAS, As Management Systems Director for the Bipartisan
10 Management Committee, Ms. Brown oversaw the installation of the
11 air-blown fiber optic infrastructure for the Capitol Complex,
12 which was the first installation of air-blown fiber in this
13 Commonwealth; and

14 WHEREAS, The House of Representatives acknowledges Ms.
15 Brown's faithful performance of her statutorily defined duties
16 and her personal dedication to House members and staff; and

17 WHEREAS, The House of Representatives wishes Ms. Brown much
18 happiness in the coming years; therefore be it
