AN ACT

- 1 Requiring information relating to parenting and prenatal
- depression, postpartum depression, postpartum psychosis and
- other emotional trauma counseling and screening to be
- 4 provided to a pregnant woman; and providing for the powers
- and duties of the Department of Health.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Prenatal and
- 10 Postpartum Counseling and Screening Act.
- 11 Section 2. Counseling information and screening.
- 12 (a) Duty to provide. -- A hospital, birthing center,
- 13 physician, nurse-midwife or midwife who provides prenatal care
- 14 to a pregnant woman during gestation or at delivery of an infant
- 15 shall:
- 16 (1) Provide the woman with a fact sheet that includes
- 17 common symptoms of the medical conditions of prenatal
- depression, postpartum depression and postpartum psychosis
- and for emotional traumas associated with pregnancy and

1 parenting. The fact sheet shall present, in a prominent

place, the following statement:

Prenatal depression, postpartum depression and postpartum

4 psychosis are serious medical conditions that require a

5 physician's evaluation and recommendations for treatment.

If you are suffering from any of the signs and symptoms

of these conditions, you should immediately inform your

8 treating physician or psychiatric physician.

- (2) Provide the woman with a resource list of the names, addresses and telephone numbers of professional organizations that provide prenatal counseling, postpartum counseling and assistance to parents.
- (3) Screen the woman for postpartum depression symptoms prior to discharge from the birthing facility and at the first few postnatal check-up visits.
- 16 (4) Document in the patient's record that the patient
 17 received the information described in paragraph (1).
- 18 (5) Retain the documentation for at least three years in 19 the hospital's, birthing center's, physician's, nurse-20 midwife's or midwife's records.
- 21 (b) Resources to be included. -- The information under
- 22 subsection (a) shall include resources a pregnant woman may
- 23 contact to receive treatment, counseling and assistance for the
- 24 medical conditions of prenatal depression, postpartum depression
- 25 and postpartum psychosis and for emotional traumas associated
- 26 with pregnancy and parenting.
- 27 (c) Presumption of compliance. -- A hospital, birthing center,
- 28 physician, nurse-midwife or midwife who provides prenatal care
- 29 to a woman during gestation or at delivery is presumed to have
- 30 complied with this section if the woman received prior prenatal

- 1 care from another hospital, birthing center, physician, nurse-
- 2 midwife or midwife in this Commonwealth during the same
- 3 pregnancy.
- 4 Section 3. Powers and duties of the Department of Health.
- 5 The Department of Health shall:
- 6 (1) Adopt and promulgate rules and regulations if
- 7 necessary to carry out the purposes and provisions of this
- 8 act.
- 9 (2) Enforce this act and the rules and regulations
- 10 promulgated under this act.
- 11 (3) Make available on the department's Internet website
- 12 a printable list of professional organizations that provide
- 13 pregnancy counseling and assistance to parents, along with a
- fact sheet and the statement as referenced in section 2(a)
- 15 (1).
- 16 (4) Update the list required under paragraph (3) on a
- monthly basis.
- 18 Section 4. Effective date.
- 19 This act shall take effect in 60 days.
