6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Section 2 of the act of August 15, 1961 (P.L.987,
9	No.442), known as the Pennsylvania Prevailing Wage Act, amended
10	August 9, 1963 (P.L.653, No.342), is amended to read:
11	Section 2. DefinitionsAs used in this act
12	(1) "Department" means Department of Labor and Industry of
13	the Commonwealth of Pennsylvania.
14	(2) "Locality" means any political subdivision, or
15	combination of the same, within the county in which the public
16	work is to be performed. When no workmen for which a prevailing
17	minimum wage is to be determined hereunder are employed in the
18	locality, the locality may be extended to include adjoining
19	political subdivisions where such workmen are employed in those

1 crafts or trades for which there are no workmen employed in the 2 locality as otherwise herein defined. 3 (3) "Maintenance work" means the repair of existing facilities when the size, type or extent of such facilities is 4 5 not thereby changed or increased. The term includes the following actions taken on roads: 6 7 (i) Replacement in kind, or compliance with current 8 Department of Transportation design criteria and standards, of quide rails, curbs, pipes, line painting and other related road 9 10 equipment. 11 (ii) Repair of pavement service by: 12 (A) laying bituminous material up to three and a half inches 13 thick or up to four hundred twenty pounds per square yard on asphalt pavement, cement concrete or other hard surface, 14 including associated milling, and related work raising existing 15 16 paved shoulders to new grade; or 17 (B) patching of cement concrete surface to include joint spalling and repair work. 18 19 (iii) Widening of existing alignment which does not result in additional lanes or new shoulders. 20 (iv) Bridge cleaning, washing, resurfacing with blacktop, 21 minor nonstructural repairs or improvements and painting, except 22 23 when combined with complete bridge rehabilitation. 24 "Public body" means the Commonwealth of Pennsylvania, (4) any of its political subdivisions, any authority created by the 25 26 General Assembly of the Commonwealth of Pennsylvania and any instrumentality or agency of the Commonwealth of Pennsylvania. 27 28 (5) "Public work" means construction, reconstruction, 29 demolition, alteration and/or repair work other than maintenance 30 work, done under contract and paid for in whole or in part out 20150SB0351PN0258 - 2 -

1 of the funds of a public body where the estimated cost of the 2 total project is in excess of twenty-five thousand dollars 3 (\$25,000), but shall not include work performed under a 4 rehabilitation or manpower training program.

5 (6) "Secretary" means the Secretary of Labor and Industry or6 his duly authorized deputy or representative.

7 (7) "Workman" includes laborer, mechanic, skilled and semi-8 skilled laborer and apprentices employed by any contractor or 9 subcontractor and engaged in the performance of services 10 directly upon the public work project, regardless of whether 11 their work becomes a component part thereof, but does not 12 include material suppliers or their employes who do not perform 13 services at the job site.

14 (8) "Work performed under a rehabilitation program," means 15 work arranged by and at a State institution primarily for 16 teaching and upgrading the skills and employment opportunities 17 of the inmates of such institutions.

18 (9) "Advisory Board" means the board created by section 2.119 of this act.

(10) "Appeals Board" means the board created by section 2.2of this act.
