AN ACT

Amending the act of December 10, 1974 (P.L.852, No.287), 1 entitled "An act to protect the public health and safety by preventing excavation or demolition work from damaging 3 underground lines used in providing electricity, communication, gas, propane, oil delivery, oil product delivery, sewage, water or other service; imposing duties 5 6 upon the providers of such service, recorders of deeds, and 7 persons and other entities preparing drawings or performing excavation or demolition work; and prescribing penalties," 9 further providing for the definition of "line" or "facility." 10 The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. The definition of "line" or "facility" in section 1 of the act of December 10, 1974 (P.L.852, No.287), referred to 14 15 as the Underground Utility Line Protection Law, amended November 29, 2006 (P.L.1593, No.181), is amended to read: 16 17 Section 1. As used in this act: 18 19 "Line" or "facility" means an underground conductor or 20 underground pipe or structure used in providing electric or

21 communication service, or an underground pipe used in carrying,

- 1 gathering, transporting or providing natural or artificial gas,
- 2 petroleum, propane, oil or petroleum and production product,
- 3 sewage, water or other service to one or more transportation
- 4 carriers, consumers or customers of such service and the
- 5 appurtenances thereto, regardless of whether such line or
- 6 structure is located on land owned by a person or public agency
- 7 or whether it is located within an easement or right-of-way. The
- 8 term shall include unexposed storm drainage and traffic loops
- 9 that are not clearly visible. The term shall not include crude
- 10 oil or natural gas production and gathering lines or facilities
- 11 unless the line or facility:
- 12 (1) is a regulated onshore gathering line as defined in
- 13 regulations promulgated after January 1, 2006, by the United
- 14 States Department of Transportation pursuant to the Pipeline
- 15 Safety Act of 1992 (Public Law 102-508, 49 U.S.C. § 60101 et
- 16 seq.), if the regulated gathering line is subject to the damage
- 17 prevention program requirements of 49 CFR § 192.614[.]; or
- 18 (2) is a gathering line, as defined in 58 Pa.C.S. §
- 19 3218.5(b) (relating to gathering lines), that is used to gather_
- 20 natural gas produced from an unconventional gas well as defined
- 21 in 58 Pa.C.S. § 2301 (relating to definitions).
