AN ACT

- 1 Establishing the Public Pensions Review Commission; providing 2 for duties; and making an appropriation.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Public
- 7 Pensions Review Commission Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Commission." The Public Pensions Review Commission
- 13 established under section 3(a).
- 14 Section 3. Public Pensions Review Commission.
- 15 (a) Establishment. -- The Public Pensions Review Commission is
- 16 established.
- 17 (b) Duties of commission. -- The commission shall:
- 18 (1) examine the Public School Employees' Retirement

- 1 System and the State Employees' Retirement System and the
- 2 condition of both systems and recommend statutory or
- 3 regulatory changes or both needed or desirable to achieve or
- 4 maintain a long-term, sound, stable public pension structure
- 5 for State and local governments;
- 6 (2) issue a final report that is based on the
- 7 examination under paragraph (1) no later than six months
- 8 after the commission is seated; and
- 9 (3) include specific recommendations and reasons for
- 10 changes in a final report.
- 11 (c) Composition. -- The commission shall be composed of the
- 12 following:
- 13 (1) The Governor or a designee.
- 14 (2) The Secretary of Revenue or a designee.
- 15 (3) The Secretary of the Budget or a designee.
- 16 (4) The Secretary of Administration or a designee.
- 17 (5) The Majority Leader of the Senate or a designee.
- 18 (6) The Minority Leader of the Senate or a designee.
- 19 (7) The Majority Leader of the House of Representatives
- 20 or a designee.
- 21 (8) The Minority Leader of the House of Representatives
- 22 or a designee.
- 23 (9) The Director of the Administrative Office of
- 24 Pennsylvania Courts or a designee.
- 25 (10) The Chancellor of the State System of Higher
- 26 Education or a designee.
- 27 (11) The President of The Pennsylvania State University
- 28 or a designee.
- 29 (12) The Chancellor of the University of Pittsburgh or a
- 30 designee.

- 1 (13) The President of Temple University or a designee.
- 2 (14) The President of Lincoln University or a designee.
- 3 (15) The Executive Director of the Pennsylvania League
- 4 of Municipalities or a designee.
- 5 (16) The Executive Director of the County Commissioners
- 6 Association of Pennsylvania or a designee.
- 7 (17) The Executive Director of the Pennsylvania State
- 8 Association of Township Supervisors or a designee.
- 9 (18) The Executive Director of the Pennsylvania State
- 10 Association of Boroughs or a designee.
- 11 (19) The Executive Director of the Pennsylvania School
- 12 Boards Association or a designee.
- 13 (20) Three representatives of public employee unions.
- 14 (21) Three public members who possess expertise in
- issues relating to public pensions. Each of the following
- shall appoint one public member:
- 17 (i) The Governor.
- 18 (ii) The President pro tempore of the Senate.
- 19 (iii) The Speaker of the House of Representatives.
- 20 (d) Appointments. -- An appointment under subsection (c) (20)
- 21 or (21) shall be made within 30 days of enactment.
- 22 (e) Vacancies. -- A committee vacancy on account of a vacancy
- 23 in an office under subsection (c)(1), (2), (3), (4), (5), (6),
- 24 (7), (8), (9), (10), (11), (12), (13), (14), (15), (16), (17),
- 25 (18) or (19) shall be filled by an acting officer.
- 26 (f) Quorum. -- A majority of appointed members shall
- 27 constitute a quorum for the purposes of conducting business.
- 28 (g) Transparency and ethics. -- The commission shall be
- 29 subject to the following laws:
- 30 (1) The act of February 14, 2008 (P.L.6, No.3), known as

- 1 the Right-to-Know Law.
- 2 (2) 65 Pa.C.S. Chs. 7 (relating to open meetings) and 11
- 3 (relating to ethics standards and financial disclosure).
- 4 (3) The act of July 19, 1957 (P.L.1017, No.451), known
- 5 as the State Adverse Interest Act.
- 6 (h) Transparency and ethics. -- The commission may conduct
- 7 hearings and otherwise gather pertinent information and analysis
- 8 that it considers appropriate.
- 9 (i) Logistical and other support. -- The commission shall
- 10 receive logistical and other support from the Joint State
- 11 Government Commission and may employ additional temporary staff
- 12 as needed.
- 13 (j) Reimbursement.--The members of the commission shall be
- 14 reimbursed for reasonable expenses.
- 15 Section 4. Appropriation.
- The sum of \$1,000,000 is hereby appropriated to the
- 17 commission for the commission's operations under this act.
- 18 Section 5. Effective date.
- 19 This act shall take effect in 60 days.
