- Amending the act of February 9, 1999 (P.L.1, No.1), entitled "An act providing for borrowing for capital facilities; 2 conferring powers and duties on various administrative 3 agencies and officers; making appropriations; and making repeals," in capital facilities, further providing for 5 definitions and for appropriation for and limitation on 6 7 redevelopment assistance capital projects. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Paragraphs (2) and (3) of the definition of 11 "redevelopment assistance capital project" in section 302 of the act of February 9, 1999 (P.L.1, No.1), known as the Capital 12 13 Facilities Debt Enabling Act, amended October 25, 2013 (P.L.648, 14 No.77), are amended to read: 15 Section 302. Definitions. 16 The following words and phrases when used in this chapter 17 shall have the meanings given to them in this section unless the 18 context clearly indicates otherwise:
