Transfers prohibited. -- There is no authority 9 for the State Treasurer, the Secretary of the Budget, the 10 Secretary of Revenue or the Pennsylvania Gaming Control Board to transfer any money within or between the appropriations in Part 11 12 III. Section 502. Effective date. -- This act shall take effect 13 14 July 1, 2015, or immediately, whichever is later.
