- 14 person for 90 days upon receiving a certified record of the
- driver's conviction, adjudication of delinquency or admission
- into an accelerated rehabilitative disposition program or a
- 17 preadjudication program for a violation of subsection (a), if
- 18 the certified conviction indicates the violation resulted in
- serious bodily injury to another person. The license shall be
- 20 surrendered in accordance with section 1540 (relating to
- 21 surrender of license).
