AN ACT

- Designating a bridge on that portion of State Route 711 over the Loyalhanna Creek in Ligonier Township, Westmoreland County,
- as the Lieutenant Eric Eslary Memorial Bridge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Lieutenant Eric Eslary Memorial Bridge.
- 7 (a) Findings. -- The General Assembly finds and declares as
- 8 follows:
- 9 (1) Lieutenant Eric Eslary was a native of Ligonier,
- 10 Westmoreland County, and a 17-year veteran of the Ligonier
- 11 Township Police Department.
- 12 (2) On May 5, 2015, Lieutenant Eslary was patrolling
- 13 Route 30 in Ligonier Township with his K-9 partner, Blek,
- 14 when his marked SUV was hit head on by a van operated by a
- driver under the influence and driving the road the wrong
- 16 way. Lieutenant Eslary sustained ultimately fatal injuries
- and his K9 partner required veterinarian care. At the scene,
- 18 Blek refused to leave his partner's side.

- 1 (3) Lieutenant Eslary was a well-respected and committed
- 2 law enforcement officer who established his department's K-9
- 3 unit in 2000 and provided K-9 training assistance to other
- 4 departments across this Commonwealth. He was an instrumental
- 5 part of the Westmoreland County Drug Task Force through which
- 6 he provided drug abuse resistance education to local school
- 7 children and civic organizations.
- 8 (4) In addition to his duties with the police
- 9 department, Lieutenant Eslary was a long-time volunteer with
- 10 the Wilpen Fire Department, where he founded successful
- fundraising efforts. He was also a member of the local
- 12 Masonic chapter and volunteered with various youth sports
- associations in the county.
- 14 (b) Designation. -- The bridge located on State Route 711 in
- 15 Ligonier Township, Westmoreland County, over the Loyalhanna
- 16 Creek is hereby designated the Lieutenant Eric Eslary Memorial
- 17 Bridge.
- 18 (c) Signs. -- The Department of Transportation shall erect and
- 19 maintain appropriate signs displaying the name of the bridge to
- 20 traffic in both directions on the bridge.
- 21 Section 2. Effective date.
- This act shall take effect in 60 days.
