A RESOLUTION

- Designating the week of June 12 through 18, 2016, as
 "Pennsylvania Family Center Network Week" in Pennsylvania.

 WHEREAS, Pennsylvania Family Centers are early childhood,

 parent education and family support programs serving families

 throughout pregnancy until children enter school; and
- 6 WHEREAS, Family centers promote the protective factors that
- 7 keep families strong by increasing parent knowledge and
- 8 practices, providing early detection of developmental delays and
- 9 health issues, preventing child abuse and neglect, meeting
- 10 concrete needs, increasing children's school readiness and
- 11 school success, connecting families with each other and
- 12 increasing family involvement and leadership in the community;
- 13 and
- 14 WHEREAS, All young children and their families deserve the
- 15 same opportunities to succeed regardless of any demographic,
- 16 geographic or economic considerations; and
- 17 WHEREAS, Family center services are tailored to the resources
- 18 and needs of the communities served; and

- 1 WHEREAS, Family centers serve 4,733 families with 6,843
- 2 children enrolled in the Parents as Teachers (PAT) home visiting
- 3 program and hundreds more families with support services; and
- 4 WHEREAS, PAT is the evidence-based program used by all
- 5 Pennsylvania Family Centers; and
- 6 WHEREAS, PAT's vision is that all children will learn, grow
- 7 and develop to reach their full potential; and
- 8 WHEREAS, PAT's mission is to provide the information, support
- 9 and encouragement parents need to help children develop
- 10 optimally during the crucial early years of life; and
- 11 WHEREAS, Family centers affirm PAT's position that parents
- 12 are children's first and most influential teachers and that the
- 13 early years of life are critical for optimal development and
- 14 provide the foundation for success in school and life; and
- WHEREAS, PAT is federally recognized as an evidence-based
- 16 model program because it meets rigorous standards for
- 17 effectiveness; and
- 18 WHEREAS, Family centers support goals related to economic
- 19 stability, healthy children in healthy homes and school
- 20 readiness of children through strength-based work with families,
- 21 including the use of the PAT model; and
- 22 WHEREAS, The Commonwealth invests more than \$3 million in
- 23 family centers; and
- 24 WHEREAS, More than 60% of Pennsylvania's population lives in
- 25 the 28 counties served by family centers in urban, rural and
- 26 suburban communities; and
- 27 WHEREAS, Sixty-five percent of the families served are
- 28 considered high risk due to low educational attainment, poverty
- 29 or disability; and
- 30 WHEREAS, Established and emerging research should be the

- 1 foundation of parent education and family support curricula,
- 2 training, materials and services; therefore be it
- 3 RESOLVED, That the Senate designate the week of June 12
- 4 through 18, 2016, as "Pennsylvania Family Center Network Week"
- 5 in Pennsylvania.
