AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- provisions applicable as well to private and parochial 3
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in school health services, providing
- for administration of epinephrine auto-injectors by school 6
- bus drivers. 7
- The General Assembly of the Commonwealth of Pennsylvania 8
- hereby enacts as follows:
- 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 11 as the Public School Code of 1949, is amended by adding a
- 12 section to read:
- Section 1414.9. Administration of Epinephrine Auto-injectors 13
- 14 by School Bus Drivers.--The provisions of 42 Pa.C.S. §§ 8332
- 15 (relating to emergency response provider and bystander good
- 16 Samaritan civil immunity) and 8337.1 (relating to civil immunity
- of school officers or employees relating to emergency care, 17
- first aid and rescue) shall apply to a school bus driver when 18

- 1 <u>all of the following apply:</u>
- 2 (1) The school bus driver administers an epinephrine auto-
- 3 injector to a student in a manner consistent with the policies
- 4 <u>established by all of the following:</u>
- 5 (i) the independent contractor that employs the school bus
- 6 driver, if the school bus driver is employed by an independent
- 7 contractor;
- 8 (ii) the school entity that has contracted with the
- 9 <u>independent contractor</u>, if the school bus driver is employed by
- 10 <u>an independent contractor; and</u>
- 11 (iii) the school entity that employs the school bus driver,
- 12 if the school bus driver is employed by a school entity.
- 13 (2) The school bus driver has successfully completed a
- 14 training program that shall be developed and implemented by the
- 15 Department of Health. The Department of Health shall have ninety
- 16 (90) days from the effective date of this section to develop and
- 17 implement such a training program.
- 18 Section 2. This act shall take effect in 60 days.
