AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
2 act relating to the public school system, including certain
3 provisions applicable as well to private and parochial
4 schools; amending, revising, consolidating and changing the
5 laws relating thereto," in terms and courses of study,
6 providing for handwriting instruction required; and, in
7 charter schools, further providing for provisions applicable
8 to charter schools and for applicability of other provisions
9 of this act and of other acts and regulations.

10 The General Assembly of the Commonwealth of Pennsylvania
11 hereby enacts as follows:

12 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
13 as the Public School Code of 1949, is amended by adding a
14 section to read:

15 Section 1528. Handwriting Instruction Required.--The board
16 of school directors in every school district shall develop
17 curriculum on handwriting instruction in grades kindergarten
18 through five. The curriculum shall be designed to ensure that
19 students have the ability to:

20 (1) write legibly in print by the end of third grade; and

21 (2) write legibly in cursive by the end of fifth grade.

Section 2. Sections 1732-A(a) and 1749-A(a)(1) of the act, amended November 3, 2016 (P.L.1061, No.138), are amended to read:

Section 4 of the act of January 25, 1966 (1965 P.L.1546, No.541), entitled "An act providing scholarships and providing funds to secure Federal funds for qualified students of the Commonwealth of Pennsylvania who need financial assistance to attend postsecondary institutions of higher learning, making an appropriation, and providing for the administration of this act."

Act of July 12, 1972 (P.L.765, No.181), entitled "An act relating to drugs and alcohol and their abuse, providing for projects and programs and grants to educational agencies, other public or private agencies, institutions or organizations."
