AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- Pennsylvania Consolidated Statutes, in juries and jurors,
- further providing for exemptions from jury duty.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 4503(a) of Title 42 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- 8 adding a subsection to read:
- 9 \$ 4503. Exemptions from jury duty.
- 10 (a) [General rule] <u>Exemptions</u>.--No person shall be exempt
- 11 [or excused] from jury duty except the following:
- 12 (1) [Persons in active service of the armed forces of
- the United States or of the Commonwealth of Pennsylvania.]
- (Reserved).
- 15 (2) [Persons who have served within three years next
- 16 preceding on any jury except a person who served as a juror
- for fewer than three days in any one year in which case the
- exemption period shall be one year.] (Reserved).

- 1 (3) [Persons demonstrating to the court undue hardship
 2 or extreme inconvenience may be excused permanently or for
 3 such period as the court determines is necessary, and if
 4 excused for a limited period shall, at the end of the period,
 5 be assigned to the next jury array.] (Reserved).
 - (4) Spouses, children, siblings, parents, grandparents and grandchildren of victims of criminal homicide under 18
 Pa.C.S. § 2501 (relating to criminal homicide).
- 9 (5) Persons who have previously served [for a term of 18 months] on a Statewide investigating grand jury[, including any extensions thereof,] who opt not to serve.
- 12 (6) Persons 75 years of age or older who [request to be excused] opt not to serve.
- 14 (7) Judges and magisterial district judges of the
 15 Commonwealth [and judges of the United States as defined in
 16 28 U.S.C. § 451 (relating to definitions)] who opt not to
 17 serve.
- 18 (8) [Breastfeeding women who request to be excused.]
 19 (Reserved).
- 20 <u>(9) Judges of the United States as defined in 28 U.S.C.</u>
 21 § 451 (relating to definitions) who opt not to serve.
- 22 (a.1) Excusals. -- The following persons may be excused from
- 23 jury duty upon request for such period as the court determines
- 24 necessary and, at the end of the period, be assigned to the next
- 25 jury array:

- 26 <u>(1) Persons demonstrating to the court undue hardship or</u> 27 extreme inconvenience.
- 28 (2) Persons in active service of the armed forces of the
 29 United States or of the Commonwealth of Pennsylvania.
