AN ACT

1 2 3 4 5 6 7 8 9 10 11 12 13 14 15	Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating and defining membership of county boards of elections; imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to elections," in primary and election expenses, further providing for definitions, for reporting by candidate and political committees and other persons and for late contributions and independent expenditures and providing for independent expenditures and electioneering communications.
16	The General Assembly of the Commonwealth of Pennsylvania
17	hereby enacts as follows:
18	Section 1. The General Assembly finds and declares as
19	follows:
20	(1) The Commonwealth has a compelling interest in:
21	(i) Providing voters with relevant information about
22	where political campaign money comes from and how it is
23	spent so that voters can make informed choices in
24	elections.

(ii) Reducing the risk or appearance of undue
 influence by ensuring political spending is
 comprehensively disclosed.

4 (iii) Promoting compliance by candidates and
5 political groups with campaign finance laws.

6 (2) Under existing law, a person that purchases 7 political advertisements that expressly advocate for the 8 election or defeat of a candidate is subject to disclosure 9 requirements, but a person that purchases advertisements to 10 influence elections without expressly advocating for a 11 candidate is not subject to disclosure requirements.

12 (3) As a result, Pennsylvania has seen a proliferation 13 of advertisements featuring candidates that are distributed 14 during the campaign season and are intended to influence 15 elections but are not required to be reported under existing 16 law.

17 (4) Disclosure of expenditures intended to influence
18 elections should begin at an amount that is reasonable and
19 intended to promote full disclosure of the expenditures.

(5) It is the intent of the General Assembly to subject
all persons that make expenditures to influence elections,
whether through express advocacy or election-targeted issue
advocacy, to disclosure requirements.

Section 2. Section 1621(e) of the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, is amended and the section is amended by adding subsections to read:

28 Section 1621. Definitions.--As used in this article, the 29 following words have the following meanings:

The words "independent expenditure" shall mean an 1 (e) 2 expenditure by a person [made for the purpose of influencing an election], other than a political committee or candidate, 3 expressly advocating the election or defeat of a clearly 4 identified candidate, made without cooperation or consultation 5 with any candidate or any political committee authorized by that 6 candidate and which is not made in concert with or at the 7 8 request or suggestion of any candidate or political committee or 9 agent thereof. * * * 10 (n) The words "electioneering communication" shall mean a 11 12 communication by a person, other than a political committee or candidate, that is publicly distributed within sixty (60) days 13 14 before a primary, special, municipal or general election and refers to a clearly identified candidate or to a question 15 appearing on the ballot. The term does not include: 16 17 (1) A communication distributed by a means other than by a 18 communications media. 19 (2) A membership communication. 20 (3) A communication appearing in a news article, opinion or 21 commentary, provided that the communication is not distributed 22 via any communications media owned or controlled by a candidate, 23 political committee or the person purchasing the communication. 24 (4) A communication made in a candidate debate or forum or 25 which solely promotes a debate or forum and is made by or on 26 behalf of the person sponsoring the debate or forum. 27 (5) Any other communication exempted by regulation by the Secretary of the Commonwealth that is consistent with this 28 29 article. 1	the name, a photograph or a drawing of the candidate appears or

4	(p) The words "communications media" shall mean television,
5	radio, newspaper or other periodical, sign, publicly accessible
6	<u>Internet website, mail or telephone.</u>
7	(q) The words "membership communication" shall mean a
8	newsletter or periodical, telephone call or other routine
9	communication distributed solely to the members, shareholders or
10	employees of an organization or institution.
11	(r) The words "responsible party" shall mean a natural
12	person who shares or exercises discretion or control over the
13	activities of an entity required to file reports in accordance
14	with section 1626(g). The term includes an officer, director,
15	partner, proprietor or other natural person who exercises
16	discretion or control over the activities of an entity.
17	(s) The word "sign" shall mean an outdoor billboard, panel
18	or similar display having an area of at least ninety (90) square
19	<u>feet.</u>
20	Section 3. Sections 1626(g) and 1628 of the act are amended

25	(g) Every person, other than a political committee or
26	candidate, who makes independent expenditures [expressly
27	advocating the election or defeat of a clearly identified

a calendar year shall file with the appropriate supervisor, on a 1 2 form prepared by the Secretary of the Commonwealth, a report 3 which shall include the same information required of a candidate or political committee receiving such a contribution and, 4 additionally, the name of the candidate or question supported or 5 opposed. Reports required by this subsection shall be filed on 6 7 dates on which reports by political committees making 8 expenditures are required to report under this section.] or electioneering communications in an aggregate amount exceeding 9 five hundred dollars (\$500) during a calendar year shall file a 10 11 report, on a form prepared by the Secretary of the Commonwealth, 12 with the appropriate supervisor. The following shall apply: 13 (1) The report shall include the following information: 14 (i) Relating to the person making the independent expenditure or electioneering communication: 15 16 (A) The full name and mailing address of the person. 17 (B) If the person is not an individual, the full name and 18 mailing address of its officers, one of whom shall be an 19 individual named as its treasurer. 20 (C) A concise statement of the person's purposes or goals. 21 (D) The name, office sought and party affiliation of a 22 candidate whom the person is supporting or opposing and, if the 23 person is supporting the entire ticket of a party, the name of 24 the party. 25 (E) If the independent expenditure or electioneering 26 communication refers to a ballot question, a description of the 27 ballot question. 28 (F) If the person files reports with the Federal Election 29 Commission or an out-of-State agency, a statement to that effect, including the name of the agency. 30

5	been made during the calendar year in an aggregate amount in
6	<u>excess of one hundred dollars (\$100).</u>
7	(B) The amount, date and purpose of each independent
8	expenditure or electioneering communication.
9	(C) The name of and office sought by each candidate on whose
10	behalf the independent expenditure or electioneering
11	communication was made or the ballot question supported or
12	opposed.
13	(iii) The full name and mailing address of each person who
14	has made contributions to the person making the independent
15	expenditure or electioneering communication during the calendar
16	year in an aggregate amount in excess of one hundred dollars
17	(\$100), the total of all contributions from the person during
18	the calendar year, and the amount and date of all contributions
19	from the person during the calendar year.

21	subparagraph (iii) is not an individual, the following
22	information:
23	(A) The full name and mailing address of a person who,
24	directly or otherwise, owns a legal or equitable interest of
25	fifty (50) per cent or greater in the entity.

27	contributions made by the entity during the election period
28	exceeds one thousand two hundred dollars (\$1,200).

5 (3) If a person is required to file another report under

16 Section 1628. Late Contributions [and], Independent Expenditures and Electioneering Communications. -- Any candidate 17 18 or political committee, authorized by a candidate and created 19 solely for the purpose of influencing an election on behalf of 20 that candidate, which receives any contribution or pledge of 21 five hundred dollars (\$500) or more, and any person making an independent expenditure[, as defined by this act,] or 22 23 electioneering communication of five hundred dollars (\$500) or 24 more after the final preelection report has been deemed 25 completed shall report such contribution, pledge or expenditure 26 to the appropriate supervisor. Such report shall be sent by the candidate, chairman or treasurer of the political committee 27 28 within twenty-four (24) hours of receipt of the contribution. It 29 shall be the duty of the supervisor to confirm the substance of 30 such report. The report shall be made by <u>electronic mail</u>,

telegram, mailgram, overnight mail or facsimile transmission. 1 Any candidate in his own behalf, or chairman, treasurer or 2 candidate in behalf of the political committee may also comply 3 with this section by appearing personally before such supervisor 4 5 and reporting such late contributions or pledges. 6 Section 4. The act is amended by adding a section to read: Section 1643. Independent Expenditures and Electioneering 7 Communications. -- All independent expenditures and electioneering 8 9 communications shall prominently include the statement: 10 Paid for by (name of person paying for the independent expenditure or electioneering communication). 14 Section 5. This act shall take effect in 60 days.
