AN ACT

Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," in departmental powers and duties as to supervision, further providing for definitions <-and providing for Keystone STARS Program participants; and, 5 in departmental powers and duties as to licensing, further providing for definitions and for fees and, providing for Keystone STARS Program participants AND FURTHER PROVIDING FOR <--8 DEFINITIONS. 9 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. The definitions of "child day care" and <--"children's institutions" in section 901 of the act of June 13, 13 1967 (P.L.31, No.21), known as the Human Services Code, are 14 15 amended to read: Section 901. Definitions. As used in this article 16 17 "Child [day] care" means care in lieu of parental care given-18 for part of the twenty four hour day to a child under sixteen years of age, away from the child's home but does not include child [day] care furnished in a place of worship during

- 1 religious services.
- 2 "Children's institutions" means any incorporated or
- 3 unincorporated organization, society, corporation or agency,
- 4 public or private, which may receive or care for children, or
- 5 place them in foster family homes, either at board, wages or
- 6 free; or any individual who, for hire, gain or reward, receives
- 7 for care a child, unless he is related to such child by blood or
- 8 marriage within the second degree; or any individual, not in the
- 9 regular employ of the court or of an organization, society,
- 10 association or agency, duly certified by the department, who in-
- 11 any manner becomes a party to the placing of children in foster-
- 12 homes, unless he is related to such children by blood or
- 13 marriage within the second degree, or is the duly appointed
- 14 guardian thereof. The term shall not include a family child care-
- 15 home or child [day] care center operated for profit and subject-
- 16 to the provisions of Article X.

- 22 <u>child care provider enrolled in the Keystone STARS Program</u>
- 23 shall:
- 24 (1) conspicuously denote on its publicly accessible Internet
- 25 website, if operational, its designated STAR-level rating,
- 26 which shall include how many STARS out of four that the child
- 27 <u>care provider has received;</u>
- 28 (2) provide its STAR-level rating in writing to families at
- 29 the time of application and enrollment; and
- 30 (3) obtain a department-issued placard that denotes the

- 1 <u>child care provider's participation in the Keystone STARS</u>
- 2 Program and designated STAR-level rating.
- 3 (b) The department shall be responsible for issuing placards
- 4 to program participants. The department shall also be
- 5 responsible for designing placards in the following manner:
- 6 (1) The placards shall be clear, visible and readable by the
- 7 general public.
- 8 (2) In addition to any guidelines issued by the department
- 9 regarding the form of the placards, placards shall include the
- 10 <u>following information:</u>
- 11 (i) The name of the recipient child care provider.
- 12 <u>(ii) The name of the department.</u>
- 13 (iii) The date the department issued the placard.
- 14 <u>(iv) The number of STARS out of four that the child care</u>
- 15 provider has received.
- 16 <u>(v) The address, phone number, publicly accessible Internet</u>
- 17 website and e-mail address of the department.
- 18 <u>(vi) The web address for the publicly accessible Internet</u>

- 21 (c) Placards shall be posted in any public-facing window on

- 23 public-facing window exists, at the entrance of the child care
- 24 provider.
- 25 (d) A child care provider that fails to publicly display its <--
- 26 <u>designated STAR-level rating or alters a department-issued</u>
- 27 placard in an attempt to misrepresent the provider's STAR level_
- 28 <u>rating may be subject to any penalties that the department deems</u>
- 29 <u>appropriate</u>.
- 30 (e) The department shall ensure on an annual basis that the

- 1 STARS placard is posted and accurate.
- 2 (D) THE DEPARTMENT SHALL ENSURE ON AN ANNUAL BASIS THAT THE <--
- 3 PLACARD IS POSTED AND ACCURATE.
- 4 (E) A CHILD CARE PROVIDER THAT FAILS TO PUBLICLY DISPLAY ITS
- 5 DESIGNATED STAR-LEVEL RATING OR ALTERS A DEPARTMENT-ISSUED
- 6 PLACARD IN AN ATTEMPT TO MISREPRESENT ITS STAR-LEVEL RATING
- 7 SHALL BE CITED FOR NONCOMPLIANCE BY THE DEPARTMENT AND SHALL BE
- 8 SUBJECT TO A ONE STAR-LEVEL RATING FOR TWO YEARS.
- 9 Section 3. The definitions of "child day care," "child day <--
- 10 care center," "facility" and "family child care home" in section-
- 11 1001 of the act are amended to read:
- 12 Section 1001. Definitions. As used in this article
- 13 * * *
- 14 "Child [day] care" means care in lieu of parental care given
- 15 for part of the twenty-four hour day to children under sixteen-
- 16 years of age, away from their own homes, but does not include
- 17 child [day] care furnished in places of worship during religious-
- 18 services.
- "Child [day] care center" means any premises operated for
- 20 profit in which child [day] care is provided simultaneously for
- 21 seven or more children who are not relatives of the operator,
- 22 except such centers operated under social service auspices.

- 24 "Facility" means an adult day care center, child [day] care
- 25 center, family child care home, boarding home for children,
- 26 mental health establishment, personal care home, assisted living-
- 27 residence, nursing home, hospital or maternity home, as defined
- 28 herein, except to the extent that such a facility is operated by
- 29 the State or Federal governments or those supervised by the
- 30 department or licensed pursuant to the act of July 19, 1979

- 1 (P.L.130, No.48), known as the "Health Care Facilities Act."
- 2 "Family child care home" means a home where child [day] care-
- 3 is provided at any time to no less than four children and no
- 4 more than six children who are not relatives of the caregiver.

- 19 child care center, nursing home, hospital, personal care home,
- 20 assisted living residence and other similar institution which is
