## AN ACT

7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. The act of March 10, 1949 (P.L.30, No.14), known
0	as the Public School Code of 1949, is amended by adding an

_5	Section 2001-H. Definitions.
- 6	The following words and phrases when used in this article
_7	shall have the meanings given to them in this section unless the
8 .	<pre>context clearly indicates otherwise:</pre>
9	"Individualized Education Program" or "IEP." A written

- 1 statement for a child with a disability that is developed,
- 2 <u>reviewed or revised in a meeting in accordance with the</u>
- 3 Individuals with Disabilities Education Act (Public Law 91-230,
- 4 <u>20 U.S.C. § 1400 et seq.) and 22 Pa. Code Ch. 14 (relating to</u>
- 5 special education services and programs).
- 6 "Institution of higher education." Any of the following:
- 7 (1) An institution of the State System of Higher
- 8 <u>Education created under Article XX-A.</u>
- 9 (2) A community college created under Article XIX-A.
- 10 (3) The Pennsylvania State University, the University of
- 11 <u>Pittsburgh, Temple University, Lincoln University and their</u>
- 12 <u>branch campuses.</u>
- 13 (4) An institution as the term is defined under 24
- Pa.C.S. § 6501(a) (relating to applicability of chapter) that
- is accredited by the Middle States Commission on Higher
- 16 Education.
- 17 Section 2002-H. Student with a disability transition planning
- 18 <u>requirement.</u>
- 19 No later than upon entering the twelfth grade, IEP transition
- 20 planning for a student who is an individual with a disability
- 21 shall identify and include student goals that are likely to
- 22 continue to need to be addressed should the student attend an
- 23 institution of higher education.
- 24 Section 2003-H. Supporting students with disabilities to
- 25 <u>succeed once enrolled.</u>
- 26 An institution of higher education shall:
- 27 <u>(1) Adopt policies that, at a minimum, make the</u>
- following documentation submitted by a student sufficient to
- 29 <u>establish that the student is an individual with a</u>
- 30 disability:

Τ	(1) Documentation that the student has had an
2	individualized education program in accordance with
3	section 614(d) of the Individuals with Disabilities
4	Education Act (Public Law 91-230, 20 U.S.C. § 1414),
5	including an IEP that may not be current or up-to-date on
6	the date of the determination. The institution may ask
7	for additional documentation from the student if the
8	individual was found ineligible for services or exited
9	from eligibility under the Individuals with Disabilities
10	Education Act during elementary school.
11	(ii) Documentation that the student has had a plan
12	prepared under section 504 of the Rehabilitation Act of
13	1973 (Public Law 93-112, 29 U.S.C. § 794).
14	(iii) A plan or record of service for the student
15	from a private school, a local educational agency, a
16	State educational agency or another institution of higher
17	education provided in accordance with the Americans with
18	Disabilities Act of 1990 (Public Law 101-336, 42 U.S.C. §
19	12101 et seq.).
20	(iv) A record or evaluation from a relevant licensed
21	professional finding that the individual has a
22	disability.
23	(v) A plan or record of disability from another
24	institution of higher education.
25	(vi) Documentation of a disability due to service in
26	the uniformed services as defined in section 484(c) of
27	the Higher Education Act of 1965 (Public Law 89-329, 20
28	<u>U.S.C. § 1091).</u>
29	(2) Adopt policies that are transparent and explicit
30	regarding information about the process by which the

- institution of higher education determines eligibility for

  accommodations relating to students with disabilities and how
- 3 <u>such issues are addressed.</u>
- 4 (3) Disseminate the information to students, parents and
- 5 <u>faculty in an accessible format, including during a student</u>
- 6 <u>orientation, and make the information readily available on a</u>
- 7 publicly available Internet website of the institution of
- 8 <u>higher education.</u>
- 9 Section 2. This act shall take effect in 60 days.
